

Alternate Contract Source (ACS) No. 78102200-17-ACS For Courier Services

This Contract is between the State of Florida, Department of Management Services (Department), an agency of the State of Florida and United Parcel Services, Inc., 55 Glenlake Parkway, Atlanta, Georgia 30328 (Contractor), collectively referred to herein as the "Parties."

The Department is authorized by subsection 287.042(16), Florida Statutes, "to evaluate contracts let by the Federal Government, another state, or a political subdivision for the provision of commodities and contract services, and, if it is determined in writing to be cost-effective and in the best interest of the state, to enter into a written agreement authorizing an agency to make purchases under such contract."

The State of Utah acting by and through the National Association of State Procurement Officials (NASPO) ValuePoint, competitively procured small package delivery services, and signed contract number MA065 with the Contractor, attached hereto as Exhibit C (Master Agreement). The Master Agreement is effective November 28, 2016 and terminates on November 27, 2021. There are no renewal options available. The Department evaluated the Master Agreement, and hereby acknowledges that use of the Master Agreement is cost-effective and in the best interest of the State.

Accordingly, the Parties agree as follows:

I. Initial Contract Term.

This Contract will be effective on November 28, 2016 or on the date the Contract is signed by all Parties, whichever is later, through November 27, 2021, consistent with the Master Agreement, unless terminated earlier in accordance with the General Contract Conditions.

II. Renewal Term.

Upon mutual written agreement, the Parties may renew this Contract, in whole or in part, for a Renewal Term not to exceed the Initial Contract Term, pursuant to the incorporated General Contract Conditions.

III. Contract.

As used in this document, "Contract" and "ACS" (whether or not capitalized) shall, unless the context requires otherwise, include this document and all incorporated Exhibits, which set forth the entire understanding of the Parties and supersedes all prior agreements. All modifications to this Contract must be in writing and signed by all Parties.
