TITLE: Approve Updated Expenditures for Custodial Services at Lee County Sports Parks & Stadiums

#### I. MOTION REQUESTED

Approve increase to annual expenditures for custodial services at Lee County Sports Parks and Stadiums from Clean 17, Inc. d/b/a Jan-Pro Cleaning Systems of Southwest Florida in the total annual amount not to exceed \$163,000.00.

### II. ITEM SUMMARY

This item increases annual expenditures for custodial services at Lee County Sports Parks and Stadiums from Jan-Pro Cleaning Systems of Southwest Florida. Custodial services at Terry Park, Player Development Complex, City of Palms and JetBlue Stadium were underestimated. Additional services were included at JetBlue Stadium that were not considered in the annual spend. This resulted in the need to correct the anticipated expenditures with a more realistic cost. Actual projected expenditures are expected to be \$163,000 annually. Funding for this item is covered in budget.

## III. BACKGROUND AND IMPLICATIONS OF ACTION

Board Action and Other History

On October 1, 2019, the Board of County Commissioners awarded Request for Proposal No. RFP190379CJV for custodial services at Lee County Sports Parks and Stadiums to Clean 17, Inc. d/b/a Jan-Pro Cleaning Systems of Southwest Fiorida in an annual amount of \$56,692.30. At the time of contract award, the projected expenditures under this contract were underestimated. The proposed action corrects the annual spend in consideration of actual services required.

Board approval is required to increase the previously approved annual estimated amount, for a total annual expenditure of \$163,000.

Purchases made under Proposal No. RFP190379CJV for the period 10/01/19 through 01/31/2020 were \$21,787.50. Boston Red Sox Spring Training began 02/21/2020 and there will be an increase in custodial services for approximately five weeks. This will drive the cost of services up for this time period.

This Proposal No. RFP190379CJV includes three additional one-year renewals providing the county is satisfied with the level of service being provided.
