TITLE: Approve Contract Amendment for Custodial Services for Sports Parks and Stadiums

## I. MOTION REQUESTED

A) Approve Amendment No. 2 with Clean 17, Inc. d/b/a Jan-Pro Cleaning Systems of Southwest Florida, under Solicitation No. RFP190379CJV, Custodial Services for Lee County Sports Parks and Stadiums, to add the Lee County Sports Complex, formerly known as CenturyLink Sports Complex, to the custodial service locations. The amendment will increase the contract amount by \$110,000.00 annually, with total anticipated expenditures in the amount of \$273,000.00.

B) Authorize the County Manager or designee to execute the amendment on behalf of the Board of County Commissioners.

#### II. ITEM SUMMARY

Approves an amendment to the contract for custodial services for Lee County sports parks and stadiums with Jan-Pro Cleaning Systems of Southwest Florida.

On April 21, 2020 a contract was approved with Iver Facilities Management, LLC for custodial cleaning services at the Lee County Sports Complex, formerly known as CenturyLink Sports Complex, in the amount of \$110,000. Iver cancelled their cleaning contract January 21, 2022.

The amendment to the Jan-Pro contract will add Lee County Sports Complex to their service locations and increase the contract amount by \$110,000. This is net neutral for custodial services.

## III. BACKGROUND AND IMPLICATIONS OF ACTION

#### A) Board Action and Other History

April 21, 2020: the Board of County Commissioners awarded RFP200084CJV, Custodial Services for CenturyLink Sports Complex, now known as Lee County Sports Complex. The awarded vendor, Iver Facilities Management, LLC., notified Lee County on January 21, 2022, that they were cancelling the contract RFP200084CJV.

October 1, 2019: the Board of County Commissioners awarded RFP190379CJV, Custodial Services for Lee County Sports Parks and Stadiums, to Clean 17, Inc. d/b/a Jan-Pro Cleaning Systems of Southwest Florida to provide annual custodial maintenance for Terry Park, Player Development Center, City of Palms Stadium, and JetBlue Stadium. The original term of the contract was for 1-year with an option to renew for 3 additional, 1-year periods.

April 20, 2020: Amendment No. 1 was administratively approved to supplement the Agreement with provisions related to the Federal Emergency Management Agency (FEMA) from C.F.R. 200 Part II. This amendment outlined additional terms of the contract as it relates to various federal requirements: Equal Opportunity Employment, Maintenance of Records, Compliance with Federal Law, Regulations and Executive Orders.
