

SECOND AMENDMENT OF THE AGREEMENT FOR
DELIVERY SERVICES FOR LEE COUNTY LIBRARY SYSTEM

THIS SECOND AMENDMENT OF THE AGREEMENT FOR DELIVERY SERVICES FOR LEE COUNTY LIBRARY SYSTEM, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Global Courier Services, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of delivery services for Lee County Library System through Solicitation No. B180005MRH with Vendor on the 23rd day of June, 2020 ("Agreement"); and,

WHEREAS, in November 2022 the Library Administration courier service location will be changing addresses, from 2345 Union Street, Fort Myers, FL 33901 to 2201 Second Street, Suite 400, Fort Myers, FL 33901; and,

WHEREAS, to memorialize this change, the Parties desire to modify the Agreement pursuant to Article XIV. MISCELLANEOUS of the Agreement to change the address for the Library Administration courier service location, in the Exhibit A. Detailed Specifications.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The service location address change will begin on the 14th day of November, 2022


