

FIRST AMENDMENT OF THE AGREEMENT FOR
DELIVERY SERVICES FOR LEE COUNTY LIBRARY SYSTEM

THIS FIRST AMENDMENT OF THE AGREEMENT FOR DELIVERY SERVICES FOR LEE COUNTY LIBRARY SYSTEM, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Global Courier Services, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of delivery services for Lee County Library System through Solicitation No. B180005MRH with Vendor on the 23rd day of June, 2020 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the price for the purchase of delivery services for Lee County Library System; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 1st day of April, 2022; and,

WHEREAS, after the execution of the agreement it was also determined that delivery services were no longer needed for the Captiva Memorial Library; and,

WHEREAS, after the execution of the agreement the cost of fuel substantially increased and it was agreed that a Fuel Surcharge provision would be implemented, in addition to the agreed upon price increase; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XIV. MISCELLANEOUS of the Agreement to remove the Captiva Memorial Library from the Exhibit A. Detailed Specifications, modify the Route Schedule in the Exhibit A. Detailed Specifications of the Agreement accordingly, add the Fuel Surcharge to the Exhibit B. Fee Schedule, and increase the price for the purchase of delivery services for Lee County Library System, as listed in the Exhibit B. Fee Schedule.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The price increase will begin on the 1st day of April, 2022
2. The Parties agree that Captiva Memorial Library shall be removed from Section 5.4 and Section 9 of the Exhibit A. Detailed Specifications
3. The Parties agree that the following Route Schedule shall supplement the Exhibit A. Detailed Specifications of the Agreement:


