

FIRST AMENDMENT OF AGREEMENT FOR DISASTER  
RECOVERY SERVICES FOR LEE COUNTY

THIS FIRST AMENDMENT OF THE AGREEMENT FOR DISASTER RECOVERY SERVICES FOR LEE COUNTY, made and entered into on this 3 day of August, 2018 by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Crowder-Gulf Joint Venture, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of disaster recovery services, Contract No. 7753, through Solicitation No. RFP160257LAC with Vendor on the 11<sup>th</sup> day of May, 2017 ("Agreement");

WHEREAS, the Parties mutually agree to expand the Exhibit A Scope of Services to cover non-storm related disaster recovery services; and,

WHEREAS, the Parties mutually agree to add pricing for a work boat complete with crew to the Exhibit B Fee Schedule to meet the needs of the County; and

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XVI. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree to supplement the Exhibit A Scope of Services to add: "Furthermore, the Vendor shall provide services as necessary to assist in the event of any Local, State, or Federal State of Emergency is declared."
2. The Parties agree to supplement the RFP160257LAC, Disaster Recovery Services for Lee County Section C: Additional Contract Items – Specialized Labor & Work Crews table in the Exhibit B Fee Schedule with the following rows:
