(Lee County Exemption No. EX140410 Merchant Services) for use on an as needed basis for acceptance of credit and debit cards and other electronic payments at the rates specified in the State of Florida Pricing Schedule, the Bank of America Merchant Pricing Schedule, and the Master Card and Visa Interchange Program Schedules, as approved in the departments' annual adopted budgets, through its extended expiration date of June 11, 2021 and any renewals or extensions approved by the State.

## II. ITEM SUMMARY

Authorizes continued use of State of Florida Department of Financial Services Division of Treasury Contract No. TR175 for use on an as needed basis for acceptance of credit cards and other electronic payments through its extended expiration date of June 11, 2021 and any renewals or extensions approved by the State. The County pays a transactional fee for this service; total fees for this service during the 2016 – 2017 Fiscal Year were approximately \$200,000.
