### I. MOTION REQUESTED

A) Approve the extension of the annual contract with nine firms under Request for Proposal No. RFP160333/DK, Environmental Maintenance Contract (Exotic Plant Control), for an additional six-month period, through March 27, 2019, for use on an as needed basis for environmental maintenance and exotic plant control, as approved in the departments' annual adopted budget: DeAngelo Brothers LLC dba Aquagenix; EarthBalance Corporation; Environmental Restoration Consultants Inc.; Mettauer Environmental Inc.; Milborne, LLC; Sandhill Environmental Services LLC; SOLitude Lake Management, LLC; Walker Exotic Tree Eradication & Mitigation LLC and Woods and Wetlands, Inc.

B) Authorize the Director of Procurement Management or designee to sign the extension documents on behalf of the Board of County Commissioners.

#### II. ITEM SUMMARY

Approve extensions of the annual contracts with nine firms for an additional six-month period through March 27, 2019, for use on an as needed basis for environmental maintenance and exotic plant control, as approved in the departments' annual adopted budget: DeAngelo Brothers LLC dba Aquagenix; EarthBalance Corporation; Environmental Restoration Consultants Inc.; Mettauer Environmental Inc.; Milborne, LLC; Sandhill Environmental Services LLC; SOLitude Lake Management, LLC; Walker Exotic Tree Eradication & Mitigation LLC and Woods and Wetlands, Inc. The six-month extension will allow the continued purchase of these services uninterrupted while the formal solicitation process is completed. Total expenditures for these services during Fiscal Year 2016-2017 were approximately \$831,076.43.

## III. BACKGROUND AND IMPLICATIONS OF ACTION

#### A) Board Action and Other History

On September 20, 2016, the Board of County Commissioners awarded Request for Proposal No. RFP160333 for environmental maintenance and exotic plant control to nine firms: DeAngelo Brothers LLC dba Aquagenix; EarthBalance Corporation; Environmental Restoration Consultants Inc.; Mettauer Environmental Inc.; Milborne, LLC; Sandhill Environmental Services LLC; SOLitude Lake Management, LLC; Walker Exotic Tree Eradication & Mitigation LLC and Woods and Wetlands, Inc. When the contracts were awarded Lake Masters Aquatic Weed Control, LLC was one of the contracts awarded, Lake Masters Aquatic Weed Control, LLC has changed the business entity name to SOLitude Lake Management, LLC. The original term of the contract was for two-years with no renewal options. Board approval will allow the continued purchase of these services uninterrupted while the formal solicitation process is completed. Total expenditures for these services during Fiscal Year 2016-2017 were approximately \$831,076.43.
