Work will be authorized, scheduled, funded, and accounted for by issuance of a Purchase Order, by the requesting department(s) or other governmental entity. However, the expenditures by Lee County for equipment rental for FY 20/21 were approximately \$268,698.68.</p> <p>Please note, the DBE goal of 4% listed within the solicitation documents refers to the Department of Transit’s (LeeTran) DBE goal set by the Federal Transit Administration (FTA) and will be taken into consideration when LeeTran utilizes FTA funds. The County encourages the utilization and participation of DBEs in procurements, and evaluation proceedings will be conducted within the established guidelines regarding equal employment opportunity and nondiscriminatory action based upon the grounds of race, color, sex or national origin.
