THIS SECOND AMENDMENT TO AGREEMENT FOR FENCING SERVICES FOR LEE COUNTY, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and V Enterprises of SWFL, LLC dba Smith Fence Company of Fort Myers, ("Vendor"), collectively, the "Parties."

WHEREAS, County and Vendor desire to enter into this Second Amendment to continue their Agreement via Solicitation No. RFP160553DKR under the Vendor's new business entity.




