FIRST AMENDMENT OF AGREEMENT FOR FORD OEM REPAIR PARTS

THIS FIRST AMENDMENT OF THE AGREEMENT FOR FORD OEM REPAIR PARTS, is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the state of Florida, hereinafter referred to as the "County," and Sam Galloway Ford, Inc., hereinafter referred to as the "Vendor."

WHEREAS, the County entered into an Agreement for Ford OEM Repair Parts, through Solicitation Number B210228DWJ, with Vendor on the 10th day of January, 2022 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the price for the purchase of Ford OEM repair parts from the Vendor; and,

WHEREAS, the Parties mutually agree that the price increase shall go into effect on November 16th, 2024; and,

WHEREAS, the Parties desire to modify the aforementioned terms of the Agreement, pursuant to Article XV. Miscellaneous of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:
