THIS EIGHTH AMENDMENT OF THE SOLID WASTE AND RECYCLING COLLECTION FRANCHISE AGREEMENT FOR LEE COUNTY SERVICE AREA NUMBER TWO, Lee County Contract No. 6320, is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Advanced Disposal Services Solid Waste Southeast, Inc. ("Contractor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of collection and hauling services for Franchise Service Area Number Two in Lee County, Contract # 6320, with Contractor on the 9th day of March, 2010 ("Agreement"); and,

WHEREAS, on the date the Agreement was executed, the Contractor's business entity name was Advanced Disposal Services Solid Waste Southeast, Inc., with a Federal Tax ID Number of 65-0858287; and,

WHEREAS, after execution of the Agreement, Waste Management, Inc. acquired Advanced Disposal Services, Inc. and became the ultimate parent company of ADS subsidiary Advanced Disposal Services Solid Waste Southeast, Inc.; and,

WHEREAS, as a result of the acquisition, WM Corporate Services, Inc. became payment agent for Advanced Disposal Services Solid Waste Southeast, Inc. ("Payment Agent") and, as Payment Agent, it provides treasury management services and receives payments on behalf of Advanced Disposal Services Solid Waste Southeast, Inc.; and,

WHEREAS, County and Contractor desire to enter into this Eighth Amendment to continue their Agreement, County Contract # 6320, with Advanced Disposal Services Solid Waste Southeast, Inc. continuing to provide services pursuant to the Agreement, and Payment Agent receiving payments from the County for the same.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Contractor shall continue to supply such products and services in accordance with the terms, conditions, and specifications of the Agreement, County Contract # 6320, including appendices and amendments, and Contractor's response.
