

## FIRST AMENDMENT OF THE ANNUAL FUEL PURCHASE AGREEMENT

THIS FIRST AMENDMENT OF THE ANNUAL FUEL PURCHASE AGREEMENT, is made by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Palmdale Oil Company, LLC ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of unleaded gasoline and diesel fuel through Solicitation B200480ANB with Vendor on the 5<sup>th</sup> day of October 2021 ("Agreement"); and,

WHEREAS, on the date the Agreement was executed, the Vendor's business entity name was Palmdale Oil Company, Inc., with a Federal Tax ID Number of 59-2358666; and,

WHEREAS, after execution of the Agreement, Palmdale Oil Company, Inc. restructured as and began operating as Palmdale Oil Company, LLC, with the same Federal Tax ID Number of 59-2358666; and,

WHEREAS, County and Vendor desire to enter into this First Amendment to continue their Agreement via Solicitation No. B200480ANB under the Vendor's new business name.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Vendor, conducting business as Palmdale Oil Company, LLC, with a Federal Tax ID Number of 59-2358666, shall continue to supply such products and services in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. B200480ANB, including appendices and amendments, and Vendor's response.
