WHEREAS, County and Vendor desire to enter into this Third Amendment to continue their Agreement via Solicitation No. B220376LLP under the Vendor's new business name.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Vendor, conducting business as SPATCO Energy Solutions, LLC, with a Federal Tax ID Number of 84-3846075, shall continue to supply such products and services in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. B220376LLP, including appendices and amendments, and Vendor's response.
