TITLE:

Award contract for General Consultant/Traffic Engineering for Transportation Facilities Bond Related Issues

ACTION REQUESTED:

1. Approve the negotiated Professional Services Agreement with CDM Smith, Inc. to provide professional services to support traffic engineering for transportation facilities bond related issues for an initial term of one year, as approved in the department's annual adopted budget.

2. Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

3. Authorize the Director of Procurement Management, with County Administration approval, to renegotiate and execute renewals of this contract for up to three additional one year periods, as approved in the department's annual budget and if doing so is in the best interest of Lee County.

FUNDING:

\$289,000 (estimated) Enterprise Fund; Included in Budget

This contract was anticipated and funding has been allocated within the Operating accounts of the Cape, Sanibel and Midpoint bridges. The negotiated contract includes a biennial bridge inspection, the first year, FY 16/17 the inspection will take place, the estimated expenditure for the first year is \$289,000. On the year when an inspection is not preformed the estimated expenditure will be \$241,000.

The deadline for submittals was November 9, 2016. The County received one submittal from the incumbent consultant. The historical data shows this service has a very limited market. The evaluation committee met December 12, 2016 to review the single proposal. The committee followed the single proposal procedure and reached a super majority to recommend for award CDM Smith, Inc.
