

FIRST AMENDMENT OF SERVICE PROVIDER AGREEMENT:
NAME CHANGE

THIS FIRST AMENDMENT OF THE SERVICE PROVIDER AGREEMENT, made and entered into on this 3 day of August, 2018 by and between the Lee County Board of County Commissioners, a political subdivision of the state of Florida, hereinafter referred to as the “County,” and Change Healthcare Technology Enabled Services, LLC, a Georgia limited liability company authorized to do business in the state of Florida, hereinafter referred to as the “Provider.”

WHEREAS, the County entered into a Service Provider Agreement, Contract Number 6918 through Solicitation Number RFP140350, with Provider on the 28th day of September, 2014 (“Agreement”); and,

WHEREAS, on the date the Agreement was executed, the Provider’s business entity name was PST Services, Inc., a McKesson Company; and,

WHEREAS, on February 28, 2017, the Provider’s business entity name was changed to PST Services LLC; and,

WHEREAS, on March 1, 2018, the Provider, previously PST Services, LLC, again changed its name to Change Healthcare Technology Enabled Services, LLC, with a Federal Tax ID Number of 58-1953146; and,

WHEREAS, County and Provider desire to enter into this First Amendment to continue their Agreement under Contract No. 6918 under the Provider’s new business name.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Provider, conducting business as Change Healthcare Technology Enabled Services, LLC, shall continue to supply such commodity or service in accordance with the terms, conditions, and


specifications of RFP140350 and Contract No. 6918, including appendices, amendments, and Provider's response.
