#### 10. Background:

Most of the County lab equipment is Hach equipment, which requires supplies from Hach Company to maintain and use. The County currently has a purchase agreement with Hach Company that will soon expire.

Procurement Management did solicit quotes under Q-120203 and received the sole response from Hach Company. This response included conditions unacceptable to the County. Therefore, in order to address the unacceptable purchase conditions, Procurement Management seeks authority to pursue direct negotiations with Hach Company regarding pricing as well as the terms and conditions of purchase.

It is anticipated the contract period will be for one year with the option to renew for four additional one year terms. The estimated annual expenditure on lab equipment and supplies is approximately \$150,000.
