

**SECOND AMENDMENT OF ANNUAL AGREEMENT FOR PURCHASE
AND DELIVERY OF HYDROFLUOSILICIC ACID 23%**

THIS SECOND AMENDMENT OF THE ANNUAL AGREEMENT FOR THE PURCHASE AND DELIVERY OF HYDROFLUOSILICIC ACID 23%, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Florida Chemical Supply, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of Hydrofluosilicic Acid 23% through Solicitation B200402DWJ with Vendor on the 25th day of January, 2021 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the rate for the purchase of Hydrofluosilicic Acid 23% from the Vendor; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 22nd day of February, 2024 and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:
