Answer	Daytime road closures will be permitted after April 9, 2023 and until November 23, 2023. Daytime road closures must be between 9:00 AM and 4:00 PM, Monday to Friday. These hours may be adjusted depending on traffic.
7.	With the Maintenance of Traffic, do they need to be during the night, and do we have to fully open the bridge back up?
Answer	Nighttime road closures will be permitted from Sunday night to Thursday night between 9:00 PM and 5:00 AM.
