SPECIAL CONDITIONS, SCOPE OF WORK & SPECIFICATIONS

1. TERM

1.1. From the Notice to Proceed or the Purchase Order date, whichever applies: <u>75</u> calendar days to substantial completion, <u>15</u> days from substantial completion to final completion (total days <u>90</u>)

2. LIQUIDATED DAMAGES (CONSTRUCTION)

2.1. In accordance with the terms set forth in the Agreement, for each consecutive calendar day of delay in achieving Final Completion as set forth herein, the CONTRACTOR shall be liable to the County for liquidated damages in the amount of \$882.00 per calendar day.

3. BASIS OF AWARD

3.1. The basis of award shall be determined by the lowest *Project Total* of the most responsive, responsible, and qualified CONTRACTOR meeting all bid specifications.

4. LOCAL PREFERENCE

4.1. The Lee County Local Vendor Preference shall be included as part of the award process for this project. As such, Lee County at its sole discretion may choose to award a preference to any qualified Local Vendor.

5. TERMS & CONDITIONS

5.1. The Construction General Conditions & Purchase Order terms and conditions shall apply to this project and can be found at https://www.leegov.com/procurement/essential-policy-and-procedures1

6. QUOTE SUBMISSION

6.1. Quote submitted by Vendor shall be good for a minimum of ninety (90) days.

7. BOND REQUIREMENTS

- 7.1. Bond requirements shall abide by the current Lee County Procurement Ordinance, Construction General Conditions, and apply only to projects over \$200,000.
 - 7.1.1. **Bid Bond** Contractor shall submit a Bid Bond in the amount of not less than five percent (5%) of the proposed dollar amount (including Alternate(s), as applicable, and shall accompany each submission.
 - 7.1.2. **P & P Bond** Awarded Contractor shall provide Performance and Payment Bonds in the amount of one hundred percent (100%) of the total Awarded Contract amount after notification by the County of the approval to award the Contract, the costs of which are to be paid by the Awarded Contractor.

8. INSURANCE REQUIREMENTS

8.1. Insurance shall be provided by the awarded bidder/vendor. Prior to execution of the Agreement/Contract a certificate of insurance (COI) complying with the bid documents shall be provided by the bidder/vendor. 9. SPECIAL CONDITIONS

9.1. If construction methods should require Maintenance of Traffic, persons possessing current valid and verifiable certificates from the appropriate courses approved by the Florida Department of Transportation and bid accordingly must perform all MOT procedures. By the Monday of two weeks prior to construction is scheduled to begin, the CONTRACTOR must notify the Project Manager so that a "Road Watch" notice can be sent to the local news media.

10. SCOPE OF WORK & SPECIFICATIONS

- 10.1. The Lee County Board of County Commissioners seeks to contract with a qualified CONTRACTOR to provide the following:
 - 10.1.1. Repair of several concrete spalling and epoxy overlay of some spots of the bridge deck. The locations of the affected areas will be identified by Lee County DOT Staff,
 - 10.1.2. Remove and replace bridge joint, and;
 - 10.1.3. Repair several spalled spots on the bridge sidewalks.
- 10.2. CONTRACTOR shall perform all concrete spall and delamination repair work in accordance with Technical Special Provision for Section T-401 Restore Spalled Areas. Materials used shall be in accordance with FDOT Standard Specifications Section 346 and on the FDOT Approved Products List (APL). Please be advised that the materials used in the project might be tested for compliance by the FDOT guidelines for material testing. The Deck overlay shall be done in accordance with FDOT Section 403 EPOXY OVERLAY FOR SEALING AND HIGH FRICTION SURFACE TREATMENT ON CONCRETE BRIDGE DECKS. Bridge Joint material must be compliant with FDOT Section 932 of the Standard Specifications for Road and Bridge Construction.
 - 10.2.1. The concrete must be cured at least for 30 days before the application of the Epoxy Overlay
 - 10.2.2 All materials need to be submitted for approval by the County before construction, to ensure compliance with the governing Technical Specifications.
- 10.3. CONTRACTOR will have access to most of the repair locations from the top of the bridge deck. Some of the concrete repairs may be the whole deck thickness which will need to be accessed from a barge or scaffolding. The areas that need to be repaired will be marked with white paint.
