- Vending machines replenishment and replacement Our current presence in the park will enhance the opportunity to replenish, service and assure park visitors receive overall superior vending service. As we have staff in the park on a daily basis, vending machine replenishment will be checked daily during peak and shoulder seasons and a minimum of three times weekly during the off season months. We currently monitor our machines daily. If a machine does break down, we will repair or replace the machine within 1 week as required.
- Applicable Code and Health Department requirements See Addendum A
- Current applicable regulatory licensing and insurances See Addendum A
- Certificates of Insurance See Addendum A
- Start up of operations can be within 30 days of contract signing.
- Hours of operation Our current presence in the park will enhance the opportunity to be open more hours. The Whistle Stop Ice Cream Shoppe will be open no less than a minimum of thirty (30) hours per week and during much of the year will be open additional hours. The Whistle Stop Ice Cream Shoppe has the added advantage of onsite managers and staff from our sister operations at Wheel Fun Rentals allowing us to operate more effectively at non peak and other marginal times.

In addition to the Ice Cream Shoppe, we will offer packaged ice cream and other packaged foods sold from multiple park locations seven days a week, 10 + hours per day (schedule may vary slightly during the slowest times of the year)

- Marketing - We will actively promote The Whistle Stop Ice Cream Shoppe, at Lakes Park utilizing advertisements in local family publications, a dedicated website, brochures distributed in area hotels and community centers and in press releases. A minimum of 4% of revenue will be expended on marketing. We will receive added exposure by cross marketing and offering discount coupons through our Wheel Fun Rentals recreational rental locations and by mentioning The Whistle Stop Ice Cream Shoppe in all Wheel Fun Rentals marketing efforts.



- Group activities and special events - We will actively promote birthday parties and other special events where in we will offer discounts on ice cream and since we do recreational rentals in Lakes Park, we will also offer group discounts on rental products, tying together a fun, healthful recreational experience.

We plan to offer bundled packages for groups (i.e. birthday parties) that will include bike/boat rentals, train tickets, and ice cream and/or cake.

Special events: We plan to offer seasonal events like a Pumpkin Patch in October, Holiday Express evening concession coverage in December, and eventually an Easter event when park renovation is complete.

- Pricing and overall pricing policies will be to assure prices are similar to goods and services found in comparable venues. And though our pricing will be comparable (& in some cases lower due to park clientele), our service will be exemplary (see Attachment A for food pricing).

### Criteria 3 - Corporate Experience and Capacity

In addition Scott and John are franchisees of Wheel Fun Rentals who operate recreational rental and food concessions in over 30 parks across the country, generating well in excess of one million dollars in food service.

WFR has sufficient capital availability and cash flow to support the necessary investment to launch the Whistle Stop Ice Cream Shoppe. We have already shown our commitment

to investing capital back into Lakes Park (i.e. rental fleet, floating dock, etc.) and are clearly committed to the long run success of Lakes Regional Park.





Vending machine posted refund policy - We have found with our rental business that it is very important for the vending machine operator to provide daily service. Our employees have fielded many complaints from patrons who have lost money, etc. and simply assumed they were our machines. We feel we can provide daily service and have staff on site at both ends of the park to eliminate frustrated visitors.

We have the capability to provide these machines in a few weeks from when the contract is awarded. All vending machines will be equipped with "Vendor Miser" energy saving devices. Initially we will not have credit card capability on these machines due to the uncertain volume of sales that these machines will generate. We do however realize the importance of credit cards to our business and will offer this at the ice cream shoppe. We would certainly invest in this technology for the vending machine if volume is sufficient.

#### Menu will include

- Bottled and fountain beverages
- Coffee Drinks




