# MOTION REQUESTED

A) Approve Piggyback No. PB210294DWJ to utilize pricing on Sourcewell Contract No. 060920 Class 4-8 Chassis with Related Equipment, from Navistar, Inc. dba International Truck through authorized dealers, for the purchase of original equipment manufacturer parts with related equipment, accessories, and services, on an as needed basis, through the contract expiration date of August 1, 2024, and any renewals or extensions approved by Sourcewell. Expenditures will be on an needed basis as approved in the departments' annual adopted budgets. Individual purchases in excess of \$100,000.00 will be brought to the Board for approval.
B) Grant the County Manager or designee the authority to execute any documents necessary to utilize the piggy back for purchases on behalf of the Board of County Commissioners.

### II. ITEM SUMMARY

Approves the use of the competitively solicited Sourcewell Contract for Class 4-8 Chassis with Related Equipment, Accessories, and Services from Navistar, Inc. dba International Truck, for the purchase of original equipment manufacturer parts with related equipment, accessories, and services on an as needed basis through the contract expiration date of August 1, 2024, and any renewals or extensions approved by Sourcewell. Expenditures will be on an as needed basis as approved in the departments' annual adopted budgets. Individual purchases in excess of \$100,000.00 will be brought to the Board for approval. Use of the piggyback represents savings of 34.5% to 54% off list price according to the model specific discounts offered by Navistar, Inc. dba International Truck.

Sourcewell awarded new contracts to Peterbilt Motors Company, The Lion Electric Co., West-Mark (Certified Stainless), National Auto Fleet Group, Crane Carrier Company, Autocar Truck, Navistar, Inc., Kentworth Truck Company, and Mack Trucks. Use of the piggyback represents savings of 34.5% to 54% off list price according to the model specific discounts offered by Navistar, Inc. dba International Truck.
