1. ACTION REQUESTED/PURPOSE:

1. Approve award of Formal Quotation No. Q-120079/Landscape Maintenance for DOT Roadways to the following local vendors: Hannula Landscaping and Irrigation, Inc. – Sections 1, 2 and 5; P & T Lawn & Tractor Service, Inc. (a DBE vendor) – Sections 4A, 7, 8 and 9; Amera-Tech, Inc., dba Florida Evergreen Landscape & Lawncare – Sections 3, 4B, 4C, 4D, 6 and 10 (all local vendors); and non-local vendor Excavation Etc., Inc. – Section 11; at the prices as listed on the attached Lee County Tabulation Sheet. The award will be valid for a period of one year, with an opportunity for four additional one year extensions.
2. Approve execution of the Service Agreement to be attached to each Purchase Order for the landscaping maintenance services.
3. Grant the Procurement Director the discretion to exercise and grant the consumer price index adjustment consistent with the quote specifications; and, the authority to negotiate and renew this quote for four additional one-year periods under the same terms and conditions, if renewal/extension is in the best interest of Lee County.

10. Background:

On January 18, 2012, the Division of Procurement received eight sealed quotations for the Landscape Maintenance for DOT Roadways. Four of the submittals did not meet specifications and were rejected. The proposed award is intended to provide maintenance of specific road segments in a manner advantageous to the public for a period of five years along the following County Roadways: Estero Parkway, Imperial Parkway, Fowler Extension, Bayshore Rd./Northeast Pine Island Rd., Lee Blvd., Six Mile Cypress, Hancock Bridge Parkway, Daniels Parkway, US41 (Jamaica Bay to San Carlos), Gunnery Rd., and San Marcos Ave./Vietnam Veterans Park.
