TITLE:

Approve Annual Bid for Landscape Maintenance and Mowing of Water, Wastewater Facilities and Wastewater Reuse Sites

ACTION REQUESTED:

A) Approve award of B-150141 Landscape Maintenance and Mowing of Water, Wastewater Facilities and Wastewater Reuse Sites to P & T Lawn & Tractor Service, Inc., for a period of one year, at an annual expenditure of not to exceed \$390,671.

B) Authorize the Procurement Director to grant an annual price increase of not to exceed 5% (based on the Consumer Price Index (CPI) 2% and the increase in service areas 3%) if deemed to be in the County's best interest to do so in accordance with the contract.

C) Grant the Procurement Director, with County Administration approval the authority to renew this agreement for four additional one-year periods at the same terms and conditions, if doing so is in the best interest of Lee County.

D) Grant the Procurement Director, with County Administration approval, the authority to act on behalf of the Board in the event of vendor non-compliance and proceed to the next low bidder(s) in the event that the low bidder is unable to establish the effectiveness of their service or comply with the specification requirements.

FUNDING:

LCU estimates annual expenditures of approximately \$390,671 for the first year and a 5% increase per year for the next four years. These services are funded from the Enterprise Fund and they are included in the LCU FY14/15 Operating Budget.

Background:

On April 7, 2015 Lee County Procurement received two sealed bids for Landscape Maintenance and Mowing of Water, Wastewater Facilities and Wastewater Reuse Sites which was done as a Two Step Process. The First Step qualified the vendors and the second step provided pricing. These documents were reviewed by an evaluation committee consisting of Chad Denney, Hank Barroso and Dennis Lang all from Lee County Utilities. Both of the vendors, P & T Lawn & Tractor Service and JSM Services Inc. were approved by the committee. P & T Lawn & Tractor was the low qualified bidder.

LCU has various annual contracts totaling the amount of \$337,000. The proposed bid is 11.7% higher than the current contract. This is mainly due to the addition of specialty services which include the slope mowing of various ponds that in the past were completed by DOT.
