I. MOTION REQUESTED

A) Approve Amendment No. 1 with Tony's Lawn and Landscape LLC, under Solicitation No. B200409DWJ, Landscape Maintenance and Mowing of Water, Wastewater, Reuse Facilities and Sites, to add two (2) additional sites to the agreement, the Solid Waste Labelle and Clewiston Transfer Stations. The amendment will increase the annual contract amount by \$22,110.

II. ITEM SUMMARY

Amends contract with Tony's Lawn and Landscape to add the Labelle and Clewiston Transfer Stations. This vendor will replace the former service provider for these locations.

III. BACKGROUND AND IMPLICATIONS OF ACTIONA) Board Action and Other History

On February 16, 2021, the Board of County Commissioners awarded B200409DWJ, Landscape Maintenance and Mowing of Water, Wastewater, to Tony's Lawn and Landscape LLC to provide maintenance and mowing services at various water, wastewater, reuse facilities and sites. The original term of the contract was for three (3) years with an option to renew for up to three (3) additional years.
