Award Contracts for Median and Roadside Landscape Maintenance and Mowing

## I. MOTION REQUESTED

- A. Award Request for Proposal No. RFP170225KLC Landscape Maintenance and Mowing for Lee County Department of Transportation (DOT) for Sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 13, 14, 15, 16, 17, 19, and 21 to P & T Lawn and Tractor Service, Inc., and Sections 10, 11, 12, 18, and 20 to Hannula Landscaping and Irrigation, Inc., to provide median and roadside landscape maintenance and mowing as approved in the department's annual adopted budget for an initial term of two years.
- B. Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- C. Grant the Director of Procurement Management the authority to negotiate renewals of the contracts, including changes in price, and to execute renewal documents for up to three additional one-year periods, with County Administration approval, as approved in the department's annual adopted budgets, if doing so is in the best interest of Lee County.
- D. Authorize the Director of Procurement Management, with County Administration approval, to add or delete work or services as needed, to approve or deny annual increases in pricing based on the Consumer Price Index as provided by the solicitation, and to execute any documents necessary for these changes.

## II. ITEM SUMMARY

Awards Request for Proposal No. RFP170225KLC Landscape Maintenance and Mowing for DOT to P & T Lawn and Tractor Service, Inc., and Hannula Landscaping and Irrigation, Inc., to provide median and roadside landscape maintenance and mowing throughout the County as listed on the Notice of intended Decision. Total annual expenditures are expected to be approximately \$1,948,124.99.

## III. BACKGROUND AND IMPLICATIONS OF ACTION

Board Action and Other History

On August 8, 2017, the Department of Procurement Management advertised Request for Proposal No. RFP170225KLC Landscape Maintenance and Mowing for DOT to solicit proposals from companies to provide median and landscape maintenance and mowing for various roads throughout Lee County. Due to Hurricane Irma, the opening date was extended to October 3, 2017. Procurement Management received a total of four bids.

On November 16, 2017, the Evaluation Committee met to evaluate the proposals received. It was decided to open proposals from the three top vendors: P & T Lawn and Tractor Service, Inc.; Hannula Landscaping and Irrigation, Inc.; and JSM Services, Inc. The committee decided to proceed and open the pricing section of the bid following the evaluation meeting. Hannula Landscaping and Irrigation, Inc., was the low bidder on many of the sections, but the vendor rescinded their bid on some of the areas.

The specific areas are outlined in the attachments and include Corkscrew Road, Cypress Lake Drive, College Parkway, Del Prado Boulevard, US 41, Hancock Bridge Parkway, Lee Boulevard, Alico Road, Treeline Avenue, and Bayshore Road
