# FIRST AMENDMENT OF AGREEMENT FOR LANDSCAPE MAINTENANCE FOR DOT

THIS FIRST AMENDMENT OF THE AGREEMENT FOR LANDSCAPE MAINTENANCE FOR DOT, made and entered into on this \_\_\_\_\_\_\_\_\_, 2018 by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and P&T Lawn & Tractor Service, Inc ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of landscape maintenance services for DOT through Solicitation RFP170225KLC with Vendor on the 18<sup>th</sup> day of January, 2018 ("Agreement"); and,

WHEREAS, there are multiple vendors performing landscape maintenance services through Solicitation RFP170225KLC and one of those vendors cannot perform the services; and,

WHEREAS, the Parties desire to transfer the services from the vendor that is unable to perform them to the Vendor pursuant to Article XVI. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that the following landscape maintenance sections and accompanying details shall be added to the Exhibit A Scope of Services:

#### Section 10:

A. U.S. 41 (Jamaica Bay to San Carlos Blvd.)

Landscape maintenance and mowing

- Medians
- Median on Island Park Rd. at U.S. 41
- B. U.S. 41 Boy Scout Drive to Gladiolus Dr.
  - Medians only
- C. U.S. 41 San Carlos Blvd. to Bonita Springs City Limit
