A) Approve Piggyback No. PB230611DWJ to utilize pricing on the Sourcewell Contract No. 031121-TTC for Grounds Maintenance Equipment, Attachments, and Accessories with Related Services, for the purchase of lawn and maintenance equipment and accessories, on an as-needed basis, through the contract expiration date of April 30, 2025, and any renewals or extensions approved by Sourcewell, as approved in the departments' annual adopted budgets. Individual purchases in excess of \$100,000.00 will be brought to the Board for approval.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the County Manager or designee the authority to renew the contract, for up to one additional year, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewal.
