

FIRST AMENDMENT OF THE AGREEMENT FOR
LEE COUNTY DOT ROADWAY LIGHTING

THIS FIRST AMENDMENT OF THE AGREEMENT FOR LEE COUNTY DOT ROADWAY LIGHTING is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Consolidated Electrical Distributors, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement to purchase LED roadway lighting fixtures, through Solicitation No. B200271MIF, with Vendor on the 16th day of October, 2020 ("Agreement"); and,

WHEREAS, it was discovered after the execution of the Agreement that it would be in the best interests of the County to supplement the Exhibit B, Fee Schedule, to include additional LED fixtures; and,

WHEREAS, pursuant to Article XV. Miscellaneous of the Agreement, the Parties desire to modify the Exhibit B, Fee Schedule, of the Agreement to add the additional fixtures.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

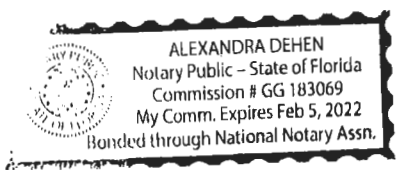
