Approve Amending Contract with Consolidated Electric Distributors

MOTION REQUESTED I.

A) Approve Amendment No. 2 to the contract with Consolidated Electrical Distributors, Inc., under Solicitation No. B200271MIF, Lee County DOT Roadway Lighting, to increase the price of providing LED roadway lighting fixtures. The amendment will increase the unit pricing by 3.71% on average, with total annual anticipated expenditures not to exceed amount of \$450,000.00, as previously approved. B) Approve contract renewal for the purchase of LED roadway lighting fixtures, from Consolidated Electrical Distributors, Inc., under Solicitation No. B200271MIF, through October 5, 2024, in the not to exceed amount of \$450,000.00.

C) Authorize the County Manager or designee to execute the amendment on behalf of the Board of County Commissioners.

ITEM SUMMARY II.

Approves a contract amendment with Consolidated Electrical Distributors, Inc., under the solicitation for the Lee County DOT Roadway Lighting, to increase the price of providing LED roadway lighting fixtures. The amendment will increase the unit pricing by 3.71% on average, with total anticipated expenditures not to exceed amount of \$450,000.00. Total expenditures during Fiscal Year 2021 - 22 were \$348,349.45. Approves the contract renewal through October 5, 2024.

BACKGROUND AND IMPLICATIONS OF ACTION III.

> On October 5, 2020, the Board of County Commissioners awarded B200271MIF Lee County DOT Roadway Lighting to Consolidated Electrical Distributors, Inc., for providing LED roadway lighting fixtures on an as-needed basis. The original term of the contract was for three-years with an option to renew for up to three (3) additional years. The Board approved a not-to-exceed amount of \$450,000 per year for this service. This action does not change the previously approved not-toexceed amount, this action allows for the vendor to charge on average 3.71% more on their unit pricing.
