NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Vendor, conducting business as Lodestar Claims & Risk Services, Inc., with a Federal Tax ID Number of 23-2652239, shall continue to supply such products and services in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. RFP220126CJV, including appendices and amendments, and Vendor's response.
