2. QUESTIONS/ANSWERS

1.	Will the winning vendor be responsible for removing current equipment being replaced?
Answer	No, the winning vendor will not be responsible for removing current equipment being replaced. The removal of existing equipment will be completed by the County.
2.	We would like to request a one-week extension to the due date.
Answer	The proposal opening date/time shall remain as stated within the solicitation document. Proposals are due Wednesday, July 13, 2022 by 2:30 PM to the Lee County Procurement Management office located at 2115 Second Street, 1st Floor, Fort Myers, FL 33901.
3.	Regarding the 52 self-checkout stations - what is the breakdown between kiosk/freestanding and tabletop units? Does the Library need credit/debit and/or cash payment devices? Media unlocking? Novelist? Any other add-ons to be considered?
Answer	Vendors should provide costs for kiosk/freestanding and tabletop units, if available, so that the County can determine the best solution for each location. Vendors should include costs to add credit/debit payment terminals to the self-check kiosks to pay fines and fees. Vendors should include costs for integrated or attachable media unlocker options, if available. All hardware, software, and add-ons required as part of the proposed solution should be detailed and included in the pricing portion of the proposal. Any additional options and respective costs beyond the scope of the proposal can be provided in a separate section.
4.	12 RFID security gates - what are the dimensions of the entrances? Please confirm single, dual, or triple aisle, etc. configurations.
Answer	The libraries are open to the public if the vendors need to conduct due diligence and field measurements. The library addresses and security gate configurations are listed within Addendum 1.
