

THIRD AMENDMENT OF AGREEMENT FOR LUBRICANT PRODUCTS

THIS THIRD AMENDMENT OF THE AGREEMENT FOR LUBRICANT PRODUCTS, is made by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Flamingo Oil Corporation ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of lubricant products through Solicitation B170172TJM with Vendor on the 11th day of October, 2017 ("Agreement"); and,

WHEREAS, it was discovered after the full execution of the Agreement that the County requires a additional lubricants product not currently provided for by the Agreement; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. Miscellaneous of the Agreement to correct this error.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:




