Terms and Conditions **Request for Proposal**

1. DEFINTIONS

- 1.1. **Addendum/Addenda**: A written change, addition, alteration, correction or revision to a bid, proposal or contract agreement. Addendum/Addenda may be issued following a pre-bid/pre-proposal conference or as a result of a specification or work scope change to the solicitation.
- 1.2. **Approved Alternate**: Solicitation documents may make reference of specific manufacturer(s) or product(s). These references serve only as a recommendation and a guide to minimum quality and performance. The references are not intended to exclude approved alternatives of other manufacturer(s) or product(s).
- 1.3. **Bid/Proposal Package**: A bid/proposal is a document submitted by a vendor in response to some type of solicitation to be used as a basis for negotiations or for entering into a contract.
- 1.4. **Bidder/Responder/Proposer**: One who submits a response to a solicitation.
- 1.5. **County**: Refers to Lee County Board of County Commissioners.
- 1.6. **Due Date and Time/Opening**: Is defined as the date and time upon which a bid or proposal shall be submitted to the Lee County Procurement Management Division. Only bids or proposals received prior to the established date and time will be considered.
- 1.7. **Liquidated Damages**: Damages paid usually in the form of monetary payment, agreed by the parties to a contract which are due and payable as damages by the party who breaches all or part of the contract. May be applied on a daily basis for as long as the breach is in effect.
- 1.8. **Procurement Management**: shall mean the Director of Lee County's Procurement Management Department or designee.
- 1.9. **Responsible**: A vendor, business entity or individual who is fully capable to meet all of the requirements of the bid/proposal solicitation documents and subsequent contract. Must possess the full capability including financial and technical, to perform as contractually required. Must be able to fully document the ability to provide good faith performance.
- 1.10. **Responsive**: A vendor, business entity or individual who has submitted a bid or request for proposal that fully conforms in all material respects to the bid/proposal solicitation documents and all of its requirements, including all form and substance.
- 1.11. **Solicitation**: An invitation to bid, a request for proposal, invitation to negotiate or any document used to obtain bids or proposals for the purpose of entering into a contract.

2. ORDER OF PRECEDENCE

- 2.1. If a conflict exists between the "Terms and Conditions" the following order of precedents will apply:
 - 2.1.1. Florida State Law as applied to Municipal Purchasing in accordance with Title XIX, "Public Business", Chapter 287 "Procurement of Personal Property and Services."
 - 2.1.2. Lee County Procurement Management Division Policy and Ordinances
 - 2.1.3. Special Conditions and Supplemental Instructions
 - 2.1.4. Detailed Scope of Work
 - 2.1.5. These Terms and Conditions

3. RULES, REGULATIONS, LAWS, ORDINANCES AND LICENSES

- 3.1. It shall be the responsibility of the proposer to assure compliance with all other federal, state, or county codes, rules, regulations or other requirements, as each may apply. Any involvement with the Lee County shall be in accordance with but not limited to:
 - 3.1.1. Lee County Procurement Policy Manual
 - 3.1.2. Pursuant to FL § Section 119.071, Public Records, General exemptions from inspection or copying of public records, sealed bids or proposals received by the County. Pursuant to this, solicitation are exempt from public records request (s. 119.07(1) and s. 24(a), Art. I, of the Florida Constitution) until such time as the agency provides notice of a decision or intended decision (pursuant to s. 119.071(2)) or within 30 days after bid or proposal opening, whichever is earlier.

- 3.1.3. Florida Statute 218 Public Bid Disclosure Act.
- 3.1.4. Florida Statute 337.168 Confidentiality of official estimates, identities of potential bidders, and bid analysis and monitoring.
- 3.1.5. FL § Section 607.1501(1) states: A foreign corporation may not transact business in the State of Florida until it obtains a certificate of authority from the Department of State.
- 3.2. **Local Business Tax**: If applicable, provide with proposal.
- 3.3. **License(s)**: Proposer should provide, at the time of the opening of the proposal, all necessary permits and/or licenses required for this product and/or service.

4. RFP – PREPARATION OF PROPOSAL

- 4.1. Proposals must be sealed in an envelope, and the outside of the envelope must be affixed with the label included in the forms section.
- 4.2. The envelope shall include:
 - 4.2.1. One (1) original hard copy of the proposal submittal, manually signed by an authorized representative.
 - 4.2.2. Six (6) electronic CD ROM or flash drive sets of the proposal submittal
 - 4.2.2.1. One single adobe PDF file and should be copied in the same order as the original hard copy.
 - 4.2.2.2. Limit the color and number of images to avoid unmanageable file sizes.
 - 4.2.2.3. Use a rewritable CD or flash drive and **do not lock files**.

4.3. **Submission Format**:

- 4.3.1. Required Forms: complete and return **all** required forms. If the form is not applicable please return with "Not Applicable" or "N/A" in large letters across the form.
- 4.3.2. Execution of Proposal: All documents must be properly signed by corporate authorized representative, witnessed, and where applicable corporate and/or notary seals affixed. All proposals shall be typed or printed in ink. The proposer may not use erasable ink. All corrections made to the proposal shall be initialed.
- 4.3.3. If a cost/bid schedule was provided in Microsoft Excel format, the returned completed schedule should be included as a Microsoft Excel File on the CD or Flash drive.
- 4.3.4. Should not contain links to other Web pages.

4.4. **Preparation Cost**:

4.4.1. The Proposer is solely responsible for any and all costs associated with responding to this solicitation. No reimbursement will be made for any costs associated with the preparation and submittal of any proposal, or for any travel and per diem costs that are incurred by any Proposer.

5. RESPONSES RECEIVED LATE

- 5.1. It shall be the proposer's sole responsibility to deliver the proposal submission to the Lee County Procurement Management Division prior to or on the time and date stated.
- 5.2. Any proposals received after the stated time and date will not be considered. The proposal shall not be opened at the public opening. Arrangements may be made for the unopened proposal to be returned at the proposer's request and expense.
- 5.3. The Lee County Procurement Management Division shall not be responsible for delays caused by the method of delivery such as, but not limited to; Internet, United States Postal Service, overnight express mail service(s), or delays caused by any other occurrence.

6. PROPOSER REQUIREMENTS (unless otherwise noted)

6.1. **Responsive and Responsible**: Only proposals received from responsive and responsible proposers will be considered. The County reserves the right before recommending any award to inspect the facilities and organization; or to take any other necessary action, such as background checks, to determine ability to perform is satisfactory, and reserves the right to reject submission packages where evidence submitted or investigation and evaluation indicates an inability for the proposer to perform.

- 6.1.1. Proposals may be declared "non-responsive" due to omissions of "Negligence or Breach of Contract" on the disclosure form. Additionally, proposals may be declared "not responsible" due to past or pending lawsuits that are relevant to the subject procurement such that they call into question the ability of the proposer to assure good faith performance. This determination may be made by the Procurement Management Director, after consulting with the County Attorney.
- 6.1.2. Additional sources may be utilized to determine credit worthiness and ability to perform.
- 6.1.3. Any proposer or sub-proposer that will have access to County facilities or property may be required to be screened to a level that may include, but is not limited to; fingerprints, statewide criminal. There may be fees associated with these procedures. These costs are the responsibility of the proposer or sub-proposer.
- 6.2. **Past Performance**: All vendors will be evaluated on their past performance and prior dealings with Lee County (i.e., failure to meet specifications, poor workmanship, late delivery, etc.) Poor or unacceptable past performance may result in proposer disqualification.

7. PRE-SOLICITATION CONFERENCE

- 7.1. A pre-solicitation conference will be held in the location, date, and time specified on the cover of this solicitation. The cover will also note if the pre-solicitation conference is Non-Mandatory or Mandatory. All questions and answers are considered informal. All prospective proposers are encouraged to obtain and review the solicitation documents prior to the pre-proposal so they may be prepared to discuss any questions or concerns they have concerning this project. All questions must be submitted formally in writing to the procurement staff noted on the first page of the solicitation document. A formal response will be provided in the form of an addendum (see "County Interpretation/Addendums" for additional information.) A site visit may follow the pre-proposal conference, if applicable.
- 7.2. **Non-Mandatory**: Pre-solicitation conferences are generally non-mandatory, but it is highly recommended that prospective proposers participate.
- 7.3. **Mandatory**: Failure to attend a mandatory pre-solicitation conference will result in the proposal being considered **non-responsive**.

8. COUNTY INTERPRETATION/ADDENDUMS

- 8.1. Each proposer shall examine the solicitation documents and shall judge all matters relating to the adequacy and accuracy of such documents. Any inquiries, suggestions or requests concerning interpretation, clarification or additional information pertaining to the solicitation shall be made in writing, submitted at least eight (8) calendar days prior to the date when the proposal is due.
- 8.2. Response(s) will be in the form of an Addendum posted on www.leegov.com/procurement. It is solely the proposer's responsibility to check the website for information. No notifications will be sent by Lee County Procurement Management Division.
- 8.3. All Addenda shall become part of the Contract Documents.
- 8.4. The County shall not be responsible for oral interpretations given by any County employee, representative, or others. Interpretation of the meaning of the plans, specifications or any other contract document, or for correction of any apparent ambiguity, inconsistency or error there in, shall be in writing. Issuance of a written addendum by the County's Procurement Management Division is the only official method whereby interpretation, clarification or additional information can be given.

9. QUALITY GUARANTEE/WARRANTY (as applicable)

- 9.1. Proposer will guarantee their work without disclaimers, unless otherwise specifically approved by the County, for a minimum of twelve (12) months from final completion.
- 9.2. Unless otherwise specifically provided in the specifications, all equipment and materials and articles incorporated in the work covered by this contract shall be new, unused and of the most suitable grade for the purpose intended. Refurbished parts or equipment are not acceptable unless otherwise specified in the specifications. All warrantees will begin from the date of final completion.
- 9.3. Unless otherwise specifically provided in the specifications, the equipment must be warranteed for twelve (12) months, shipping, parts and labor. Should the equipment be taken out of service for more than forty-

- eight (48) hours to have warranty work performed, a loaner machine of equal capability or better shall be provided for use until the repaired equipment is returned to service at no additional charge to the County.
- 9.4. If any product does not meet performance representation or other quality assurance representations as published by manufacturers, producers or distributors of such products or the specifications listed, the vendor shall pick up the product from the County at no expense to the County. The County reserves the right to reject any or all materials, if in its judgment the item reflects unsatisfactory workmanship or manufacturing or shipping damage. The vendor shall refund, to the County, any money which has been paid for same.

10. SUBSTITUTION(S)/APPROVED ALTERNATE(S)

- 10.1. Unless otherwise specifically provided in the specifications, reference to any equipment, material, article or patented process, by trade name, brand name, make or catalog number, shall be regarded as establishing a standard of quality and shall not be construed as limiting competition. If a proposer wishes to make a substitution in the specifications, the bidder shall furnish to the County, no later than ten (10) business days prior to the solicitation opening date, the name of the manufacturer, the model number, and other identifying data and information necessary to aid the County in evaluating the substitution. Such information is submitted through the Procurement Management Division. Any such substitution shall be subject to County approval through the issuance of a written addendum by the County's Procurement Management Division. Substitutions shall be approved only if determined by the County to be an Approved Alternate to the prescribed specifications.
- 10.2. A proposal containing a substitution is subject to disqualification if the substitution is not approved by the County. Items bid must be identified by brand name, number, manufacturer and model, and shall include full descriptive information, brochures, and appropriate attachments. Brand names are used for descriptive purposes only. An **Approved Alternate** product or service may be used.

11. ADDITIONS, REVISONS AND DELETIONS

11.1. Additions, revisions, or deletions to the Terms and Conditions, specifications that change the intent of the solicitation will cause the solicitation to be non-responsive and the proposal will not be considered. The Procurement Management Director shall be the sole judge as to whether or not any addition, revision, or deletion changes the intent of the solicitation.

12. NEGOTIATED ITEMS

- 12.1. Any item not outlined in the Scope of Services may be subject to negotiations between the County and the successful Proposer.
- 12.2. After award of this proposal the County reserves the right to add or delete items/services at prices to be negotiated at the time of addition or deletion.
- 12.3. At contract renewal time(s) or in the event of significant industry wide market changes, the County may negotiate justified adjustments such as price, terms, etc., to this contract with the County, in its sole judgment, considers such adjustments to be in the best interest of the County.

13. ERRORS, OMISSIONS, CALCULATION ERRORS (as applicable)

13.1. **Errors/Omissions:** Approval by County of the successful proposer's work product for the project shall not constitute nor be deemed a release of the responsibility and liability of the successful proposer for the accuracy and competency of the successful proposer's designs, drawings, specifications or other documents and work pertaining to the project. Additionally, approval by the County of the successful proposer's work product shall not be deemed to be an assumption of drawings, specifications or other documents prepared by the successful proposer for the project. After acceptance of the final plans by the County, the successful proposer agrees, prior to and during the construction of the project, to perform such successful proposer services, at no additional cost to the County, as may be required by the County to correct errors or omissions on the plans prepared by the successful proposer pertaining to the project.

13.2. **Calculation Errors:** In the event of multiplication/addition error(s), the unit price shall prevail. Written prices shall prevail over figures where applicable. All proposals shall be reviewed mathematically and corrected, if necessary, using these standards, prior to additional evaluation.

14. CONFIDENTIALITY

- 14.1. Proposers should be aware that all proposals provided are subject to public disclosure and will **not** be afforded confidentiality, unless provided by Chapter 119 Florida Statute.
- 14.2. If information is submitted with a proposal that is deemed "Confidential" the proposer must stamp those pages of the proposal that are considered confidential. The proposer must provide documentation as to validate why these documents should be declared confidential in accordance with Chapter 119, "Public Records," exemptions.
- 14.3. Lee County <u>will not reveal engineering estimates or budget amounts for a project</u> unless required by grant funding or unless it is in the best interest of the County. According to Florida State Statute 337.168: A document or electronic file revealing the official cost estimate of the department of a project is confidential and exempt from the provisions of s. 119.07(1) until the contract for the project has been executed or until the project is no longer under active consideration.

15. CONFLICT OF INTEREST

15.1. All proposers are hereby placed on formal notice that per Section 3 of Lee County Ordinance No. 92-22: The County is prohibited from solicitation of a professional services firm to perform project design and/or construction services if the firm has or had been retained to perform the project feasibility or study analysis.

And:

- 15.2. A professional services firm who has performed or participated in the project feasibility planning, study analysis, development of a program for future implementation or drafting of solicitation documents directly related to this County project, as the primary vendor/consulting team, cannot be selected or retained, as the primary consultant/vendor or named a member of the consulting/contracting team, to perform project design, engineering or construction services for subsequent phase(s) or scope of work for this project. Pursuant to FS. S287.057 (17) the firm will be deemed to have a prohibited conflict of interest that creates an unfair competitive advantage.
- 15.3. Should your proposal be found in violation of the above stated provisions; the County will consider this previous involvement in the project to be a conflict of interest, which will be cause for immediate disqualification of the proposal from consideration for this project.
- 15.4. **Business Relationship Disclosure Requirement**: The award hereunder is subject to the provisions of Chapter 112, Public Officers and Employees: General Provisions, Florida Statues. All proposers must disclose with their proposal the name of any officer, director or agent who is also an employee of the Lee County or any of its agencies. Further, all proposers must disclose the name of any County employee who owns directly or indirectly, an interest of five percent (5%) or more in the proposer's firm or any of its branches.

16. ANTI-LOBBYING CLAUSE (Cone of Silence)

16.1. Following Florida Statute Section 287.057(23), Upon the issuance of the solicitation, prospective proposers or any agent, representative or person acting at the request of such proposer shall not have any contact, communicate with or discuss any matter relating in any way to the solicitation with any Commissioner, Evaluation Review Committee, agent or employee of the County other than the Procurement Management Director or their designee. This prohibition begins with the issuance of any solicitation, and ends upon execution of the final contract or when the solicitation has been cancelled. If it is determined that improper communications were conducted, the Proposer maybe declared non-responsible.

17. DRUG FREE WORKPLACE

17.1. Lee County Board of County Commissioners encourages Drug Free Workplace programs as defined in accordance with Section 287.087, FL § .

18. DISADVANTAGED BUSINESS ENTERPRISE (DBE's)

- 18.1. The County encourages the use of Disadvantaged Business Enterprise Proposer(s) as defined and certified by the State of Florida Office of Supplier Diversity.
- 18.2. Bidder/Proposer is required to indicate whether the Firm and/or any proposed sub-consultants are Disadvantaged Business Enterprises (DBE). Lee County encourages the utilization and participation of DBEs in procurements, and evaluation proceedings will be conducted within the established guidelines regarding equal employment opportunity and nondiscriminatory action based upon the grounds of race, color, sex or national origin. Interested certified Disadvantaged Business Enterprise (DBE) firms as well as other minority-owned and women-owned firms are encouraged to respond.

19. ANTI-DISCRIMINATION/EQUAL EMPLOYMENT OPPORTUNITY

- 19.1. The proposer agrees to comply, in accordance with Florida Statute 287.134, 504 of the Rehabilitation Act of 1973 as amended, the Americans with Disabilities Act of 1990 (ADA), the ADA Amendments Act of 2008 (ADAAA) that furnishing goods or services to the County hereunder, no person on the grounds of race, religion, color, age, sex, national origin, disability or marital status shall be excluded from participation in, denied the benefits of, or otherwise be subjected to discrimination.
- 19.2. The proposer will not discriminate against any employee or applicant for employment because of race, religion, color, age, sex, national origin, disability or marital status. The proposer will make affirmative efforts to ensure that applicants are employed and that employees are treated during employment without regard to their race, religion, color, age, sex, national origin, disability or marital status.
- 19.3. The proposer will include the provisions of this section in every sub-contract under this contract to ensure its provisions will be binding upon each sub-contractor. The proposer will take such actions in respect to any sub-contractor, as the contracting agency may direct, as a means of enforcing such provisions, including sanctions for non-compliance.
- 19.4. An entity or affiliate who has been placed on the State of Florida's Discriminatory Vendor List (This list may be viewed by going to the Department of Management Services website at http://www.dms.myflorida.com) may not submit a bid on a contract to provide goods or services to a public entity, may not submit a bid on a contract with a public entity for the construction or repair of a public building or public work, may not submit bids on leases of real property to a public entity, may not award or perform work as a vendor, supplier, sub-contractor, or consultant under contract with any public entity, and may not transact business with any public entity.

20. PROPOSER/SUB-PROPOSER/CONSULTANT/CONTRACTOR RELATIONSHIP

20.1. The prime proposer on a solicitation may not also be listed as a sub-proposer/consultant/contractor to another firm submitting a proposal for the same solicitation. Should this occur, all responses from the involved/named firms will be considered non-compliant and rejected for award. Sub-proposers/consultant/contractor may be listed on multiple proposals for the same solicitation.

21. SUB-PROPOSER/CONSULTANT

21.1. The use of sub-proposer/consultant under this solicitation is not allowed without prior written authorization from the County representative.

22. RFP - PROJECT GUIDELINES

- 22.1. The County has established the following Guidelines, Criteria, Goals, Objectives, Constraints, Schedule, Budget and or Requirements which shall service as a guide to the proposer(s) in conforming the professional services and work to provide pursuant to this Agreement/Contract:
 - 22.1.1. No amount of work is guaranteed upon the execution of an agreement/contract.
 - 22.1.2. Hourly rates and all other negotiated expenses will remain in effect throughout the duration of the agreement/contract period.

- 22.1.3. This contract does not entitle any firm to exclusive rights to County agreements/contracts. The County reserves the right to perform any and all available required work in-house or by any other means it so desires.
- 22.1.4. In reference to vehicle travel, mileage and man-hours spent in travel time, is considered incidental to the work and not an extra compensable expense.
- 22.1.5. Lee County reserves the right to add or delete, at any time, and or all tasks or services associated with this agreement.
- 22.1.6. Any Single Large Project: The County, in its sole discretion, reserves the right to separately solicit any project that is outside the scope of this solicitation, whether through size, complexity or the dollar value.

23. RFP – EVALUATION

23.1. **Ranking Method**: Lee County uses the Dense Ranking (1223" ranking). In Dense Ranking, items that compare equal, receive the same ranking number, and the next item(s) receive the immediately following ranking number. Equivalently, each item's ranking number is 1 plus the number of items ranked above it that are distinct with respect to the ranking order. This ranking method is used for each individual committee member's scores. Thus if A ranks ahead of B and C (which compare equal) which are both ranked ahead of D, then A is ranked number 1("first"), B is ranked number 2 ("joint second"), C is also ranked number 2 ("joint second") and D is ranked number 3 ("third").

23.2. **Evaluation Meeting(s)**:

- 23.2.1. The first evaluation will rank Proposers based on the scores from the selection criteria point values.
- 23.2.2. Following the initial evaluation process, the short-listed proposer(s) will be required to provide an on-site interview/presentation.
- 23.2.3. Such subsequent evaluations will be accomplished by simply ranking the proposers. Proposers will be ranked in sequential order with one (1) being the highest ranking. Proposers' rankings will then be totaled with the total lowest scores receiving final rank order starting with one (1) the highest ranking.
- 23.2.4. Proposed short-list and final selection meeting dates are posted on the Procurement Management web page: www.leegov.com/procurement (Projects, Award Pending.)

24. RFP – TIEBREAKER

- 24.1. In the event of a tie, two or more proposers that have the same ranking, the following steps will be taken to determine the highest ranked proposer. This method shall be used for all (RFP) ties.
 - 24.1.1. Step 1: The proposer that has the highest number of 1st place rankings shall be deemed the first ranked proposer. In the event a tie still exists the proposer with the highest number of 2nd, place rankings shall be the first ranked proposer. Should a tie still remain the method used above will continue with each ranking level, 3rd, then 4th, then 5th rank, will be counted until the tie is broken.

MAINTENANCE AND REPAIR OF THE COUNTY'S FIXED NETWORK EQUIPMENT VOICE AND DATA SYSTEMS

1. INTRODUCTION & BACKGROUND

1.1 Lee County utilizes radio communications to support multiple Law Enforcement Departments and Fire-Rescue Agencies as well as Emergency Medical Services (EMS), Public Works, Utilities and Transit Operations. Additionally, there are five (5) Public Safety Answering Points (PSAP) which respond to 9-1-1 telephone calls within the jurisdictional boundaries of Lee County. The Government Communications Network (GCN) Department which is under the Division of Public Safety manages the system for approximately 6,700 radio users. A large majority of the repair, maintenance and installation services are performed by several outside contractors.

1.2 Current Radio System

The County's communications sites include both Motorola analog simulcast Smartnet and a partial APCO Project 25 (P25) overlay system. The sites are connected with a combination of microwave, fiber and leased lines. Fire and EMS agencies utilize call alert for Fire Service Alerting (FSA). There are a small number of Motorola Vehicular Radio Modems (VRM) still active supported by an RNC 3000 with data stations.

The main radio system network is comprised of a nine site, twelve channel simulcast analog 800 MHz network installed in 2000. There is a five site, eight channel 800 MHz digital APCO Project 25 (P25) system that provides radio coverage for the City of Cape Coral and Pine Island. The upgrade project also included a two site, six channel 800 MHz P25 system on Sanibel Island and a single site six channel 800 MHz P25 system on Boca Grande.

GCN also has and maintains an independent single site, six channel trunked 700 MHz digital radio system that was installed in February 2013. In addition, GCN continues to support three stand alone five (5) channel trunked analog radio systems that provide voice and wireless telemetry for Lee County Utilities and voice communications for Lee County Transit and Lee County DOT that were originally installed in 1990.

GCN supports 40 radio dispatch consoles distributed between seven E911 dispatch centers and Lee County Transit. GCN maintains two Very High Frequency (VHF) paging transmitters for Fire Service Alerting and Fire Department Volunteers. An Ultra High Frequency (UHF) repeater is used for state wide medical response and backup EMS communications. These systems are connected together with a combination of fiber-optic cable, microwave radios and leased lines.

A detailed listing and description of the online and spare equipment to be maintained is contained in Attachment A of this Request for Proposal (RFP). System and site specific connectivity, detailed operational diagrams, frequencies, programming templates, and related sensitive system information will be provided as required to the selected contractor upon award of the RFP.

2. GENERAL SCOPE OF PROJECT

2.1 Lee County requests proposals from qualified contractors for the purpose of furnishing a firm fixed price contract for the maintenance and repair of the County's Fixed Network Equipment (FNE) voice and data systems. The Contractor shall provide, including but not limited to, qualified labor, materials, repair facilities, vehicles, replacement parts, equipment transportation, training and test equipment necessary for the timely

repair or restoration of the radio system(s) operational function or performance as described in detail in this document. Any pending repairs or installations which remain during contract commencement will be completed by and the responsibility of the previous Contractor.

2.2 FNE Maintenance

1. Pre-Existing Radio System Defects

Contractor will inspect radio system spaces and equipment for any pre-existing conditions that may affect performance or system repairs. If any damaged, defective components or suboptimal system performance items are uncovered during the inspections, the system will be restored, repaired or removed from contract as decided by Radio System Managers at no cost or responsibility to contractor. County may waive the repair requirement for any remaining pre-existing defect. Any defective equipment or suboptimal performance issues with the radio system after the inspections are completed will be the responsibility of the contractor. Any pending repairs or installations which remain during contract commencement will be completed by and the responsibility of the previous contractor.

2. Maintenance Reports

Contractor will supply all repair activity details during the first week of each month for repairs which occurred the previous month. The comprehensive report will include model and serial number of the equipment, site name, agency, name of person dropping off or picking up radios, technician(s), labor time with travel time listed separately, spare serial number if utilized, description and part numbers supplied if any. These reports will be delivered to Lee County's Radio System Managers in a form and manner agreed upon by both parties.

3. Spare Equipment Management

All spare equipment is located at the Emergency Dispatch Center storage room. FNE spares will be logged in and out of the storage room with no exceptions. Information required will be the technician removing the spare, date and time, serial number of the spare and equipment description. Contractor will be responsible for replacing any equipment that has been lost or damaged during repair activity within 30 days of notification from Lee County. Any replacement parts used during the servicing of this contract or equipment that has been damaged beyond repair will be returned to Lee County for disposal unless otherwise directed by Lee County's Radio System Managers. Under no circumstances are damaged spare equipment parts, boards or assemblies to be placed back into the spares equipment room. Any failed, suspected intermittent or defective boards, parts, assemblies, or equipment replaced as a "test" will be sent out for repair and or evaluation to the manufacturer unless otherwise authorized in writing by Lee County's Radio System Managers. Contractors will not be permitted to keep or store spare equipment longer than 24 hours in their vehicles, service center, work spaces, etc. without authorization in writing from Lee County's Radio System Managers. Any equipment not considered "End of Life" and under contract that could not be economically repaired must be replaced with equipment of equal or greater quality if the equipment failed under normal wear and use. Lee County's spare equipment or resources can only be utilized to repair systems identified under the contract. Under no condition are Lee County's spare resources to be utilized to repair radio systems outside of the Lee County contract without written authorization from Lee County's Radio System Managers.

4. Damaged Equipment Management

During the course of the contract if equipment should fail and require a spare to be installed to restore the operation of the device, the defective equipment will immediately be sent by the next business day to the manufacturer for repair unless otherwise authorized in writing by Lee County's Radio System Managers. Equipment returned repaired must be re-installed into the original location to verify repair status. The spare equipment will then be returned and logged into to the spares room located at the Emergency Dispatch Center. 5. Annual Preventative Maintenance

Contractor will perform an annual Preventative Maintenance (PM) check per manufacturer's instructions. PMs must adhere at a minimum to Original Equipment Manufacturers (OEM) PM procedure and specifications. All PM procedures will be approved in writing prior to implementation by Lee County's Radio System Managers. Planned Maintenance (PM) documentation standards will be established by Lee County's Radio System Managers. Retrieval, storage and deletions of error and operational logs, physically reseating components and removal of dust and foreign particulates are just some of the items that will be required. Information provided on the document will include but not be limited to, Federal Communications Commission (FCC) required information, firmware and software versions, code plugs, frequency error, voltage or power readings along with observations before and after adjustments. Under no circumstances will information cut and pasted from the previous year's PM be allowed. Disruptive segments of the system PM procedures that will severely impair system performance, as defined by Lee County, will be performed during off peak radio usage times, typically between 0300 and 0500. All equipment covered under the maintenance contract will have the PM completed during the annual term of the contract unless otherwise authorized in writing by Lee County's Radio System Managers. System devices which are suspected to be out of tolerance in the course of a service request, must have a PM performed in addition to the annual PM. Equipment returned from a repair facility will have a PM performed prior to being reinstalled to an on line status. The additional PMs will be performed at no cost to Lee County.

6. Test Equipment

Test equipment used in the course of the PMs or day to day services must be designed and utilized in a manner approved by the manufacturer and standard for the industry. The test equipment must also be calibrated and in a good state of repair with a vendor approved by the manufacturer to their specifications. Calibrations will be performed annually with certificates of calibration available and provided on demand to Lee County. Labels which clearly indicate the calibration vendor and dates of calibration must be prominently displayed on the test equipment.

7. Repair Cycle Time

Defective equipment sent to the manufacturer for repair or repaired locally and returned to Lee County's facility must not exceed 15 business days, including shipping time. Shipping costs to and from Lee County approved repair depot or parts required for repairs must be paid by contractor. Re-installation of repaired equipment into the original location may not exceed an additional 5 business days. Lee County's Radio System Managers must be notified of any additional time required in writing and the reason for the delay. Documentation such as shipping tracking numbers, date of initial service, backorders, and manufacturer or other Lee County approved repair facility communications must be made available if requested. Repaired spares are to be delivered and stored at the Lee County Emergency Dispatch Center Storage room in an area designated for this purpose until the repair process is complete. Chain of custody

documentation will be required in a format approved by Lee County Radio System Managers. Contractor will maintain all historical repair and service records for each piece of equipment for the entire term of the contract and provide them to Lee County at any time.

8. Severity Levels

Severity levels will initially be defined by dispatch services. The technician responding to the call may modify the severity level upon review and size up of failure information. Lee County Radio Managers, in their sole discretion, reserve the right to modify the severity level at any time for any reason.

Severity 1 - 100% Complete System Failure. No voice trunking, dispatch consoles or data processing system wide on Primary Dispatch Systems.

Severity 2 - 30% or more of system impairment. Portions of the radio system(s) no longer function, are severely impaired or have a rapidly escalating defect.

Severity 3 – Failure or intermittent stable defect which reduces operational efficiency, functionality or other core services. Loss of single remote site.

Severity 4 – Minor problem with little or no noticeable impact on radio users, request for information or system status.

9. Response Times

Severity 1 - 5 minutes by phone 35 minutes on site

Severity 2 - 15 minutes by phone 45 minutes on site

Severity 3 - 1 hour by phone 2 hours on site

Severity 4 - 24 hours by phone or next business day.

10. System Restoration

Severity 1 - 2 Hours (Partial or Full Restoration)

Severity 2 – 4 Hours (Partial or Full Restoration)

Severity 3 – 8 Hours

Severity 4 - 40 Hours (Resolution)

11. Above Contract Warranty

All billable above contract services including but not limited to, repairs, installations, modifications or upgrades performed by contractor will be warranted for ninety (90) days from the time of repair, installation or modification completion date. Any subsequent repairs for faulty workmanship or repairs for the same defect, on the same piece of equipment during the ninety (90) day period or repairs to ancillary equipment that is damaged directly due to repair activities under warranty or not will be repaired at no cost to Lee County.

12. Ineffective Performance

Ineffective performance is defined as multiple attempts to resolve the same defect for the same device, equipment or system problem, improperly diagnosing system defects or to be unsuccessful in the timely remedy of a system fault or suboptimal system performance. Contractor must then seek assistance in the defect resolution in a timely manner to minimize the negative impact on Lee County's radio system users. Lee County in its sole discretion will identify, assist and direct contractor to contact manufacturer system expertise to help in the resolution of the defects utilizing but not limited to, manufacturer's technical support, field engineers, product specialists or system technologists. Any costs for the additional services will be the responsibility of the contractor. If contractor is unable or unwilling to provide the additional services, Lee County will contact the system specialists and may apply any

resultant invoice as a credit to the pending contractor's monthly invoice for the maintenance agreement unless the root cause defect was outside of the contractor's control or specifically excluded from the contract.

13. New Equipment Replacements

Contractor may be required to install new replacement equipment on the radio system. If the new equipment should fail during the manufacturer warranty period, contractor will remove, ship, receive, reinstall, calibrate, program, provision or any other activity to restore operation to the equipment following manufacturer's recommendations. If the replaced equipment was functionally under contract and identified on the equipment inventory on Attachment A, then costs for this repair activity after the warranty expires, will be considered covered under the existing maintenance contract and the responsibility of the contractor. New replacement equipment will have the same function of the manufacturer approved equipment but may not be the same manufacturer, model, series, software release or form factor as the unit it replaced. The original replaced equipment will be removed from the inventory list.

14. Force Majeure

Contractor will not be responsible for any system defects that results from power surges, lightning events, neglect, corrosive liquids or gases, physical damage, Radio Frequency Interference (RFI) or other force majeure events outside of contractor's direct control. Notarized affidavits will be required from the technician and/or the manufacturer under these conditions, clearly stating the probable cause of the failed hardware or equipment. Any efforts by contractor to restore services under these conditions will be considered billable and County may be invoiced accordingly.

15. System Documentation

System specific documentation including but not limited to, parts lists, diagrams, schematics, pictures, recordings, blue prints, service and training manuals or presentations that were existing or created during the course of the contract will remain the property of Lee County and must not be copied, deleted, removed, or distributed without written permission of Lee County's Radio System managers.

16. Stock Repair Parts

Contractor will stock parts and supplies in sufficient quantity available locally as required to maintain system operations at a level that will not unduly impair system performance, reliability or timely repairs. Parts should be on hand to reasonably meet mandated system restoral times. Substitutions for parts other than sourced from manufacturer must be approved by Lee County's Radio System managers and be of equal or greater quality.

17. Product Service Bulletins

Contractor must proactively review "Product Service Bulletins" or similar documents from the manufacturers of the equipment under contract for hardware or software defects that could affect the performance of Lee County's system(s). Contractor must arrange a date and time for the application of the hardware or software correction with the customer. Fleet impact analysis may be required prior to implementation. Any costs for the upgrades must be paid by manufacturer and or contractor unless otherwise approved by Lee County Radio System Managers.

18. Advance Replacement

Advance replacement is where a spare unit will be shipped "Next Day" in advance of the shipment, repair and return of defective equipment. In the event spare systems equipment inventory is depleted or reduced to a critical level as defined by County, advance replacement services will be required. Inventory List, Attachment "A" identifies spare equipment that will have "Advance Replacement" options. Advance replacements will be fully functional, working spares and should only require a minimum of field programming and optimization. Shipping costs for Advance Replacement components will be paid by contractor.

19. End of Life Equipment Best Effort Repairs

End of Life equipment is defined as the manufacturer will no longer accept defective components for repair, respond to technical inquiries or supply replacements. Several components in Lee County's radio system are beyond or will reach end of life during the term of the contract. Spare parts are available locally as well as regionally if necessary. Contractor will attempt best effort repairs utilizing local resources to achieve system restoration. If out of County, travel time is required to retrieve additional resources in an attempt for system restoration, the reasonable travel time will be invoiced on a time and material basis to Lee County in accordance with GSA rates. Actual repair time at the equipment location will be considered covered under the maintenance contract.

20. Above Contract Services and Invoicing

Time and materials for above contract activities will be required from time to time. Quotes for preplanned activities will be provided by the contractor to Lee County and invoiced accordingly. Quotes will be in a format approved by Lee County's Radio System Managers. Labor Services will be broken down by hours estimated and parts will be indentified by manufactures number and priced individually. All parts including but not limited to, materials, assemblies, cables and software costs will have a minimum of percentage off manufacturers published list price. Lee County reserves the right to order parts directly or hire additional subcontractors during the course of the planned project. Unplanned or emergency services may be required and verbal approval can be given from Lee County's Radio System Managers for these additional above contract activities. Technician may be required to provide logs in these instances showing the time of request for services and completion. Check in with dispatchers, customer signatures or other documentation may be required by Lee County. Invoices for any above contract billable services must be received by Lee County Finance within 60 days of work completion.

21. Technicians

Contractor will provide appropriate licenses and or product specific training certificates to verify technical abilities. All technicians working on the County's systems must produce evidence of training and certification relevant to the technology and areas they will be expected to service. Including but not limited to, FCC licenses, CET Associate, Journeyman or Master, Certified Wireless Technology Specialist, R56, Network+, product specific training documents, equivalent training or certificates. Technical staff provided by the contractor will possess a neat and professional appearance as well as effective verbal and written communications skills. Contractor will provide uniforms with company logo to technical staff. Technicians responding to Lee County service requests must have the minimum test equipment and resources with them to reasonably perform their duties efficiently and independently. Sharing test equipment, vehicles, software, manuals, cables, parts, or any other resources between technicians, retrieving the resources from another location other than their assigned service vehicle, using

Lee County's test equipment or resources to subsidize repair services, or used to repair customer's equipment outside of this contract will not be allowed unless authorized in writing by Lee County's Radio System Managers. Contractor is responsible for ensuring that any substitute or replacement personnel have comparable skills and experience. Resumes must be submitted for approval by Lee County Radio System Managers as applicable for replacement or substitute personnel. County reserves the right to interview substitute or replacement personnel prior to any commencement of repair activity or access to Lee County's radio systems. County shall be entitled to request the removal of individuals working on Lee County's systems for any of the following grounds, provided that such request be in writing and shall specify the reasons for the County's dissatisfaction:

- Unsatisfactory performance that causes negative operational impact at the County or causes the County to commit additional resources to avoid negative operational impact
- Dishonest or belligerent conduct
- Lack of compatibility with County staff
- Violation of County rules or policies
- Criminal Activity

22. Vehicles

All drivers and vehicles should meet all State licensing and registration and safety requirements and shall be equipped properly in accordance with City, State, Federal and OSHA requirements. The Contractor should obtain insurance coverage for all vehicles as required by law in Florida. All vehicles should be in good working, reliable condition and well kept in appearance. Contractor's vehicles should have Contractor's company name and/or logo displayed on doors or side panels and shall be in letters large enough to be easily legible from a distance of one hundred (100) ft. Magnetic signs bearing the contractor's company name/logo are acceptable. Cost for the logo/contractor's company name shall be considered as incidental cost.

23. FNE Local Repair Qualifications

Lee County will allow local component level repairs to be performed under certain conditions. "Local Repairs" is defined as equipment that is restored to operational condition by personnel other than the manufacturer of the equipment, or at a workspace onsite or within the boundaries of Lee County. The contractor may be required to produce manufacturer's training certifications for the technicians performing board or component level repairs. Onsite stock of basic, frequently used repair parts, test equipment, solder stations designed for surface mounted components, are some but not all of the requirements for the local repair service. Lee County, in its sole discretion, reserves the right to deny local component level or other local repair services for its FNE components.

24. Network Security

Technicians, contract administrators or third party servicers may be provided network access as required to perform duties during the course of the service contract. Logins and passwords will be changed on a periodic basis. Logins and passwords are not to be shared or used by persons other than whom they were issued to. Circumventing or modifying security measures, sharing passwords or providing network information to unauthorized personnel regarding the radio system(s) or Lee Country' network will lead to immediate expulsion from all Lee County's radio network privileges and access to Lee County's or radio users spaces. Lee County's network security policies and procedures will be subject to change during the terms of the contract.

25. FNE Upgrades Removals, Replacements and Additions

Lee County may choose to replace, upgrade or remove pieces of equipment from the radio system(s) from time to time. Individual contract equipment costs previously identified in the contract will be modified to reflect these changes which will take place at the first of the month following the removal of the equipment from the contract. Additional equipment may also be added and a fair cost negotiated in good faith by both parties that will be established and added to the following month's invoice. Lee County in its sole discretion, may choose not to place the new equipment on the maintenance contract and have services provided on a time and material basis until the next contract renewal period. Response and restoration policies for the equipment will be the same as for other equipment covered under the contract and contractor will invoice the County accordingly if it applies.

26. Radio System Interference

Lee County experiences Radio Frequency Interference (RFI) from time to time. The contractor will not be responsible to correct the outside interference. Technicians will be required to positively identify the source as being outside of the radio system infrastructure and not related to a failed component covered under the contract within the radio system. Any Lee County approved research efforts to locate the source of or remedy the outside interference will be considered billable and invoiced to Lee County.

27. Third Party Equipment

Leased lines and equipment provided by third parties are installed in Lee County's radio system to provide connectivity or operational enhancements for radio sites and dispatch centers. Contractor is not responsible or under any obligation for the repair or maintenance of the Third Party equipment, transmission medium or County owned network customer premise equipment (CPE). FNE technicians must respond on site or remotely if authorized by Lee County, to review and isolate the failure to the third party equipment. Technician must then work and cooperate with third party vendor until problem has been resolved. If a dispute should arise between third party vendor and FNE technicians, Lee County will require both parties to continue repair efforts until the failure is resolved to the satisfaction of Lee County. No additional costs for these services will be allowed unless approved by Lee County's Radio System Managers regardless of the final defect resolution.

28. On Call

Technicians will be on call with 1 (one) Primary technician and 1 (one) designated Supervisor. On call technicians will respond twenty-four (24) hours per day, seven (7) days a week. On call primary and backup supervisor's calendar schedules will be provided to Lee County 24 hours prior to the beginning of the On Call period. Escalation lists will be provided for management level contact information in the event of a "Failure To Respond" incident or an emergency request for additional resources. Cell phone, home phone, email, and home addresses will be provided for each contact individual on the "On Call" and escalation lists. Updates for changes in personnel or contact information identified on the "On Call" or escalation lists will be the responsibility of the contractor and must be provided to Lee County 24 hours prior to the change in the "On Call" or escalation lists. On call technicians must reside within 30 minutes response time from Lee County's Emergency Dispatch Center.

29. Performance During Emergency

By submitting an offer, the contractor agrees and promises that, during and after a public emergency, disaster, hurricane, flood or other acts of God, the County shall be given "first priority" for all goods and services under this contract. Contractor agrees to provide all goods and services to the County during and after the emergency at the terms, conditions, and prices as provided in this solicitation on a "first

priority" basis. Contractor shall furnish a 24 hour phone number to the County in the event of such an emergency. Failure to provide the stated priority during and after an emergency shall constitute a breach in contract and make the contractor subject to sanctions from doing further business with the County.

30. Systems Monitoring

Contractor will monitor the radio systems for defects twenty-four (24) hours a day, seven (7) days a week. Contractor will provide dedicated and highly secure connectivity and equipment to monitor all systems covered under this contract for system impairment or defects. Remotely access radio system(s) to perform diagnostics to the degree allowed by County to efficiently determine course of corrective action. Create a unique incident number to track repair efforts and log all activity for Emergency Dispatch Services.

31. Emergency Dispatch Service Standards and Procedure

Emergency Dispatch Service will contact the appropriate personnel to resolve the system defects and monitor the progress of the corrective action. If the personnel are not responding according to the Severity Response table provided, emergency dispatch services will escalate contact attempts until contract personnel or County designees are located and accept the service call. If the defect cannot be resolved or service attempt is ineffective according to the System Restoral table, Emergency Dispatch Services will contact a supervisor or manufacturer product specialist to assist in the resolution. Lee County will provide sufficient documentation for customer contact, escalation lists and any action items for environmental or other service faults which fall under the responsibility of Lee County. Log all repair and contact activity to the incident number. The repair activity will be included in the monthly maintenance reports. If contractor fails to monitor or dispatch a system defect and services exceed the mandatory response or restoral times, County may chose to levy a 5% penalty per event to the contractor. This penalty will be based on the monthly cost of the contract and will be applied to the following month's invoice.

32. FNE Equipment Exclusions

Antennas, microwave dishes, coaxial cable, waveguide, lightning arrestors, antennas, air conditioners, uninterruptible power supplies (UPS), generators, automatic transfer switches (ATS), customer network premise equipment (CPE), batteries, shelters or any other equipment not reasonably or specifically identified on Exhibit **A**

33. Third Party Repair Services

Contactor must send defective equipment for out sourced repair services to the manufacturer of the equipment unless otherwise approved in writing by Lee County's Radio System Managers. This service will be provided at no cost to Lee County for any equipment covered under the contract which fails under normal wear and use.

34. Technical Support

Contractor and County will have access to technical support for all equipment covered under the contract at no additional cost to the County.
