Barbara,

nexAir historically does not list out rental categories for price increase letters but do mention the rent increase in the letter. One of the main reasons is due to how our system handles cylinder rent

Our system calculates rent based on the Rental Group and not the individual cylinder part number. If you take the first 2 letters of our part number (column A of the spreadsheet you sent) then that would be the rental group for each of the individual cylinder part numbers. Below is what I was able to pull from our system today showing the new price for each rental group that went into effect for all of businesses/entities under the cooperative agreement.
