

FIRST AMENDMENT OF PROFESSIONAL SERVICES AGREEMENT
FOR MISCELLANEOUS SURVEYING AND MAPPING - ANNUAL

THIS FIRST AMENDMENT OF THE PROFESSIONAL SERVICES AGREEMENT FOR MISCELLANEOUS SURVEYING AND MAPPING , made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Surveying And Mapping, LLC (“Consultant”), collectively, the “Parties.”

WHEREAS, the County entered into an Agreement for the purchase of miscellaneous surveying and mapping services through Solicitation CN220184DWJ with Consultant on the 26th day of September 2022 (“Agreement”); and,

WHEREAS, on the date the Agreement was executed, the Consultant’s business entity name was Hyatt Survey Services, Inc. with a Federal Tax ID Number of 03-0476653; and,

WHEREAS, after execution of the Agreement, Hyatt Survey Services, Inc. was acquired by and began operating as Surveying And Mapping, LLC with a Federal Tax ID Number of 74-2704974; and,

WHEREAS, the County and Consultant desire to enter into this First Amendment to continue their Agreement via Solicitation No. CN220184DWJ under the Consultant’s new business entity.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Consultant, conducting business as Surveying And Mapping, LLC , shall continue to supply such products and services in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. CN220184DWJ, including appendices and amendments, and Consultant’s response.
