SECOND AMENDMENT OF THE PROFESSIONAL SERVICES AGREEMENT

THIS SECOND AMENDMENT OF THE PROFESSIONAL SERVICES AGREEMENT FOR MISCELLANEOUS UTILITY ENGINEERING SERVICES, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Stantec Consulting Services Inc. ("Consultant"), collectively, the "Parties."

WHEREAS, the County executed a professional services agreement for the purchase of utility engineering services through Solicitation CN180185DLK with Consultant on the 18<sup>th</sup> day of September, 2018 ("Agreement");

WHEREAS, on the date the Agreement was executed, the Consultant's business entity name was David Douglas Associates, Inc. with a Federal Tax ID Number of 65-0692788; and,

WHEREAS, after execution of the Agreement, David Douglas Associates, Inc., was acquired by Cardno, Inc., with a Federal Tax ID Number of 45-2663666, and the First Amendment of the Agreement was executed by the Parties to assign the Agreement from David Douglas Associates, Inc. to Cardno, Inc.; and,

WHEREAS, after execution of the Agreement, Cardno, Inc. was acquired by Stantec Consulting Services Inc., with a Federal Tax ID Number of 11-2167170; and,

WHEREAS, County and Consultant desire to enter into this First Amendment to continue their Agreement via Solicitation No. CN180185DLK under the Consultant's new business name.




