TITLE: Award Contracts for Mowing and Landscape Maintenance for Lee County Libraries

I. MOTION REQUESTED

A) Award Invitation to Bid No. B210543MIF, Mowing and Landscape Maintenance for Lee County Libraries to Tony's Lawn and Landscaping LLC as Vendor responsible for Areas 1, 2 and 4 and P&T Lawn & Tractor Service, Inc. as Vendor responsible for Area 3 to purchase mowing and landscape maintenance services to all of the Library locations in Lee County, for an initial term of one (1) three-year (3) period, as approved in the department's annual adopted budget. B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners. C) Grant the County Manager or designee the authority to renew the contract, for up to three additional years, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewal.

II. ITEM SUMMARY

Awards an annual contract to two vendors to provide mowing and landscape maintenance services to all libraries in Lee County:

- Tony's Lawn & Landscaping LLC as a primary vendor responsible for Areas 1, 2 & 4 (see Analysis for area detail)
- P&T Lawn & Tractor Service Inc., as primary vendor responsible for Area 3 (see Analysis for area detail)

The County received 7 bids and selected the lowest cost for the primary vendor. Total expenditures for these services for fiscal year 2020/2021 were approximately \$373,414. Initial term of agreement is one (1) three-year period, which can be renewed for up to three additional years.

III. BACKGROUND AND IMPLICATIONS OF ACTION

Procurement Management obtained bids for the project, known as B210543MIF, Mowing and Landscape Maintenance for Lee County Libraries. On the bid deadline of November 10, 2021, Procurement Management received seven submittals. After conducting an analysis of the bid submissions, Tony's Lawn and Landscaping LLC is being recommended as a primary vendor responsible for Areas 1, 2 and 4 and P&T Lawn & Tractor Service, Inc. as primary vendor responsible for Area 3.
