FIRST AMENDMENT OF THE AGREEMENT FOR MOWING AND LANDSCAPE MAINTENANCE FOR LEE COUNTY LIBRARIES

THIS FIRST AMENDMENT OF THE AGREEMENT FOR MOWING AND LANDSCAPE MAINTENANCE FOR LEE COUNTY LIBRARIES, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Tony's Lawn and Landscaping LLC ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of mowing and landscaping services for Lee County Libraries through Solicitation No. B210543MIF with Vendor on the 30th day of March 2022 ("Agreement"); and,

WHEREAS, after the execution of the Agreement the County transferred management of the Old Bonita Springs Library and Park & Pool Area to the City of Bonita Springs and will no longer be responsible for the landscape maintenance and mowing services at that location; and,

WHEREAS, pursuant to Section 6. ADDING OR DELETING SITES OR SERVICES, of the Exhibit A. Scope of Work and Specifications, the County desires to remove the Old Bonita Springs Library and Park & Pool Area location service area from Section 23. LOCATIONS & NOTES, of the Exhibit A. Scope of Work and Specifications; and,

WHEREAS, pursuant to Article XV. Miscellaneous of the Agreement, the Parties desire to modify the Exhibit A. Scope of Work and Specifications and the Exhibit B. Fee Schedule to remove the Old Bonita Springs Library and Park & Pool Area service location.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

 Effective immediately the Old Bonita Springs Library and Park & Pool Area shall be removed from the Section 23. LOCATIONS & NOTES, of the Exhibit A. Scope of Work and Specifications and the corresponding entry in the Exhibit B. Fee Schedule shall also be removed. IN WITNESS WHEREOF this First Amendment of the Agreement has been signed and sealed, in duplicate, by the respective Parties hereto.
