



## AGREEMENT FOR PIGGYBACK PURCHASE

THIS AGREEMENT FOR PIGGYBACK PURCHASE is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Motorola Solutions Connectivity, Inc., a California corporation authorized to do business in the State of Florida, hereinafter referred to as the "Vendor".

WHEREAS, the Vendor entered into a master service agreement with Sarasota County, Contract Number 201921KW, through their Solicitation No. 201921KW on the 21st day of December, 2020 for IP selective routing, database services, network services, and call handling equipment and services for the provision of emergency communication ("Agreement"); and

WHEREAS, the Agreement is eligible for piggyback purchases; and

WHEREAS, the County desires to make purchases from the Vendor under the same terms and conditions of the Agreement..

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

The County and the Vendor agree to be bound by the terms and conditions of the Agreement with respect to the County's purchases of IP selective routing, database services, network services, and call handling equipment and services for the provision of emergency communication from the Vendor during the term of the Agreement from the effective date and any renewals or extensions thereof. The effective date shall be the date the Lee County Board of County Commissioners awarded the Solicitation to the Vendor. Chapter 119, Florida Statutes, controls this Agreement and the provisions of Chapter 119 supersede any conflicting terms.

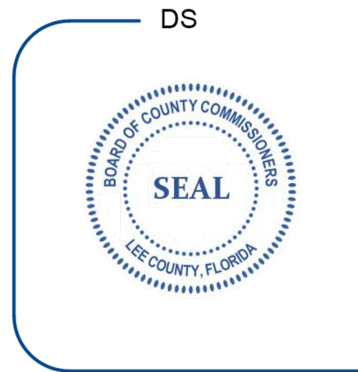
