TITLE:
Approve the purchase of Maintenance, Repair, and Operating supplies and related services.

ACTION REQUESTED:
A. Approve Piggyback No. PB170310MN for departments countywide to utilize pricing on the Maricopa County, Arizona Contract No. 16154-RFP, through the U.S. Communities Government Purchasing Alliance, for the purchase of Maintenance, Repair, and Operating Supplies and Services from HD Supply Facilities Maintenance, Ltd. for use on an as needed basis, as approved in the departments' annual adopted budgets.
B. Authorize use of the contract through its expiration date of December 31, 2021 and any renewals approved by Maricopa County, as approved in the departments' annual adopted budgets.

Funding is available in the departments' annual adopted budgets.

WHAT ACTION ACCOMPLISHES:
Approves Piggyback No. PB170310MN for the purchase of Maintenance, Repair, and Operating (MRO) supplies and related services from HD Supply Facilities Maintenance, Ltd. through Maricopa County, Arizona's contract, which went through their competitive bidding process. This contract is available to departments countywide on an as needed basis. During Fiscal Year 2015-2016, total approximate expenditures for MRO products and services from this vendor were \$18,636.43.

Background:
MRO supplies and services are used countywide by Facilities Construction and Management, Solid Waste, Community Development, Utilities, Parks and Recreation, Animal Services, and Library Services. Procurement reviewed Maricopa County, Arizona Contract No. 16154-RFP, through the U.S. Communities Government Purchasing Alliance, which went through a national competitive bidding process, and determined that the contract is available for piggyback.

During Fiscal Year 2015-2016, the total approximate expenditures for MRO products and services from HD Supply Facilities Maintenance, Ltd. were \$18,636.43.
