



AGREEMENT FOR PIGGYBACK PURCHASE

THIS AGREEMENT FOR PIGGYBACK PURCHASE is made and entered into this 28 day of September, 2018 by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and UniFirst Corporation, a Massachusetts corporation authorized to do business in the State of Florida, hereinafter referred to as the "Vendor".

WHEREAS, the Vendor entered into a contract with Sourcewell, formerly National Joint Powers Alliance (NJPA), Contract Number 062415-UFC, through their Solicitation No. RFP #062415 on the 19th day of August, 2015 for uniforms and uniform-related products and services ("Agreement"); and

WHEREAS, the Agreement is eligible for piggyback purchases; and

WHEREAS, the County desires to make purchases from the Vendor under the same terms and conditions of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The County and the Vendor agree to be bound by the terms and conditions of the Agreement with respect to the County's purchases of uniforms, uniform rental and/or related products from the Vendor during the term of the Agreement and any renewals or extensions thereof.
2. Furthermore, in consideration of County's volume, the County and the Vendor agree to the following changes which shall supersede all conflicting terms in Contract Number 062415-UFC, with all non-conflicting terms remaining in full force and effect:
 - a. No minimum stop charge of \$25.00.

- b. No charge for the initial set up, production and installation of logos and/or name emblem on shirts.
- c. The one-time cost for installation of logos on shirts for new employees and replacement shirts shall be \$1.25 each and name emblems shall be \$0.35 each.
- d. No additional charge for upsized uniform garments.
- e. The current Sourcewell contract #062415-UFC expires August 18, 2019. However, Addendum 1 to the contract states individual agency periods will still be in force upon expiration of the contract. Section F 5.23 also states: Any extension(s) of pricing beyond the specific date shall be upon mutual consent between the NJPA Member and the contract awarded Vendor. The period of County's obligation will be three (3) years (October 6, 2018 through October 5, 2021).
