**NOTES:** Individual projects shall be awarded to the Vendor that submits the lowest responsive quote. The well testing, drilling, and maintenance services shall not exceed \$200,000 for any one project without County Manager approval and shall have a maximum contract amount limit of \$5,000,000 per fiscal year, per contractor.

**Performance and Payment Bonds shall be required of individual projects with a value in excess of \$200,000 and shall be provided within ten (10) business days after notification of award.**

This is a “Master” contract, which is not for any specific project. Work will be authorized, scheduled, funded, and accounted for by the issuance of County Project Authorizations, by the requesting department.
