## EXECUTIVE SUMMARY

Recommendation to approve the selection and award contracts for RFP #15-6469 "Well Testing, Drilling, and Maintenance" to Youngquist Brothers Incorporated, Layne Christensen Company, Wells and Water Incorporated, Naples Well Drilling Incorporated, and All Webbs Enterprises, Incorporated.

**<u>OBJECTIVE</u>**: To obtain approval for the selection of vendors under Request for Proposals 15-6469 to perform testing, drilling, and maintenance on potable and irrigation wells owned and maintained by Collier County and the Collier County Water Sewer District.

**<u>CONSIDERATIONS</u>**: The Public Utilities Department maintains more than 150 wells. These wells provide both potable and irrigation water for the customers of the Collier County Water-Sewer District. The wells require periodic maintenance by well drilling and maintenance companies. Additionally, the Parks and Recreation Division maintains a series of irrigation wells throughout the parks system that also require the periodic service of a well drilling and maintenance vendor.

The maintenance activities for each well are predominantly determined by the type and the depth of the well. There are four categories of wells that require service, which include wells to 200 feet deep, wells more than 200 but less than 1,200 feet deep, deep injection wells, and aquifer storage and recovery wells.

On October 5, 2016, the Procurement Services Division released notice of Request for Proposals (RFP) 15-6469 to 880 vendors. Forty-eight solicitation packages were downloaded, and seven proposals were received December 13, 2016. The Selection Committee met February 23, 2017, and as described in the solicitation document and by consensus, ranked each of the submitted proposals. The Selection Committee recommends approval of the following vendors for award in the selected categories:

Staff recommends approving the contracts, which include a quoting process for future work by the selected vendors that was generally referenced in the RFP solicitation but omitted specific details. The selected vendors have been informed of the inclusion of the quoting process; it is now clearly articulated in the attached contracts and each of the vendors consent to the process.

**FISCAL IMPACT:** The Water, Wastewater and Parks and Recreation Divisions have funding budgeted for required maintenance of wells. For Water and Wastewater, the sources of funding are the Water User Fees Fund (412) and the Collier County Water-Sewer Operating Fund (408). Other Divisions requiring well maintenance or construction for projects shall fund such from their individual budgets. The annual historical expenditure for these services is approximately \$300,000 through various operating Divisions, but may vary based on demand and budget availability.
