TITLE: Approve Piggyback for Purchase of Tires, Tubes and Services - Countywide

I. MOTION REQUESTED

A) Approve Piggyback No. PB190265JJB to utilize pricing on the State of Florida Participating Agreement, Alternate Contract Source No. 25172500-19-ACS, through the NASPO ValuePoint Solicitation No. RFP1118005083, for the purchase of tires, tubes and services Countywide from Bridgestone Americas Tire Operations, LLC and The Goodyear Tire & Rubber Company, on an as needed basis, through the contract expiration date of January 1, 2025, and any renewals or extensions approved by the State of Florida, as approved in the departments' annual adopted budgets.

II. ITEM SUMMARY

Approves use of the State of Florida Contract through the NASPO ValuePoint solicitation for the purchase of tires and related products and services, on an as needed basis Countywide through January 1, 2025, and any renewals or extensions. Approval allows the County to purchase a wide selection of these products and services at competitive pricing through multiple vendors. Total expenditures for tires and related services and equipment for Fiscal Year 2017-2018 were approximately \$545,457.75.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

The National Association of State Procurement Officers (NASPO) ValuePoint, a non-profit cooperative purchasing organization, solicited a Request for Proposal that went through the competitive procurement process and negotiations for a Tires, Tubes and Services. NASPO awarded three contractors (Bridgestone, Continental and Goodyear). The State of Florida submitted a Participating Addendum to utilize NASPO ValuePoint's agreement, which allows all political subdivisions in the State of Florida to utilize pricing off NASPO's agreement. The State of Florida awarded two contractors, Bridgestone Americas Tire Operations, LLC and Goodyear Tire & Rubber Company, via a Participating Addendum. Lee County previously utilized NASPO's Tires, Tubes and Services agreement for its needs and recommends the approval of the piggyback.
