I. MOTION REQUESTED

Approve Piggyback No. PB190413KLC to utilize pricing on the Florida Sheriffs Association Contract No. FSA19-TRS21.0 Tire Contract which was competitively bid for the purchase of tires and related products and services on an as needed basis, from Bridgestone Americas Tire Operations, LLC; Continental Tire The America's LLC; The Goodyear Tire & Rubber Company; Maxam Tire North America, Inc.; Michelin North America, Inc.; SETCO Sales Company LLC, through February 28, 2022 and any renewals or extensions as approved by the Florida Sheriffs Association, as approved in the departments' annual adopted budget. Departmental expenditures in excess of \$100,000.00 will be brought to the Board for consideration and approval. Individual purchases at or above \$100,000 will be brought to the Board for consideration and approval.

II. ITEM SUMMARY

Authorizes purchases through the Florida Sheriffs Association for the purchase of various tires and related products and services to be used on an as needed basis from Bridgestone Americas Tire Operations, LLC; Continental Tire The America's LLC; The Goodyear Tire & Rubber Company; Maxam Tire North America, Inc.; Michelin North America, Inc.; SETCO Sales Company LLC, through February 28, 2022 and any renewals or extensions as approved by the Florida Sheriffs Association, as approved in the departments' annual adopted budget. Individual purchases at or above \$100,000.00 will be brought to the Board for consideration and approval. Total expenditures for these products during fiscal year 2017-2018 were approximately \$627,019.18.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

On April 22, 2019, the Florida Sheriff's Association opened up bidding for Florida Sheriffs Association Contract No. FSA19-TRS21.0, Tire Contract, for the purchase of tires and related products and services. The Florida Sheriffs Association provides for the purchases of various tires and related products and services at reduced pricing due to being a cooperative purchasing program with a high volume of sales.

Procurement Management has reviewed the contract and determined that it is eligible for piggyback. The piggyback provides for Countywide utilization of the reduced prices for tires and tire related services on an as needed basis from Bridgestone Americas Tire Operations, LLC; Continental Tire The America's LLC; The Goodyear Tire & Rubber Company; Maxam Tire North America, Inc.; Michelin North America, Inc.; SETCO Sales Company LLC, through February 28, 2022 and any renewals or extensions as approved by the Florida Sheriffs Association, as approved in the departments' annual adopted budget.
