

## AGREEMENT FOR PIGGYBACK PURCHASE

THIS AGREEMENT FOR PIGGYBACK PURCHASE is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Lowe's Home Centers, LLC a Florida company authorized to do business in the State of Florida, hereinafter referred to as the "Vendor".

WHEREAS, the Vendor entered into a contract with Region 4 Education Service Center Contract Number R192006, through their Solicitation No. 19-20, effective the 1<sup>st</sup> day of April, 2020 for maintenance, repair, and operations (MRO) supplies and equipment ("Agreement"); and

WHEREAS, the Agreement is eligible for piggyback purchases; and

WHEREAS, the County desires to make purchases from the Vendor under the same terms and conditions of the Agreement..

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

The County and the Vendor agree to be bound by the terms and conditions of the Agreement with respect to the County's purchases of Maintenance, Repair, and Operation (MRO) Supplies and Related Services from the Vendor during the term of the Agreement from the effective date and any renewals or extensions thereof, except that the parties agree that "Harris County, Texas" in Article 30, Indemnity, shall be superseded by "Lee County, Florida." The effective date shall be the date the Lee County Board of County Commissioners awarded the Solicitation to the Vendor.
