 Approve Piggyback for Purchase of Furniture - Countywide

I. MOTION REQUESTED

A) Approve Piggyback No. PB200348AEJ to utilize pricing on the State of Florida Contract No. 56120000-19-ACS for Furniture, All Types with the vendors made part of the contract, for the purchase of furniture, all types (except hospital room and patient handling), on an as needed basis, through the contract expiration date of December 1, 2023, and any renewals or extensions approved by the State of Florida, as approved in the departments' annual adopted budgets. Individual purchases in excess of \$100,000.00 will be brought to the Board for approval.

II. ITEM SUMMARY

A)

Approves the use of the State of Florida Contract No. 56120000-19-ACS for Furniture, All Types to provide purchase of furniture, except hospital room and patient handling from only the vendors made part of the contract, on an as needed basis, through the contract expiration date of December 1, 2023, and any renewals or extensions approved by the State of Florida. Expenditures during Fiscal Year 2018 were \$779,139.69. Individual purchases in excess of \$100,000.00 will have a market analysis completed and will be brought to the Board for approval.

III. BACKGROUND AND IMPLICATIONS OF ACTION

Board Action and Other History

The New York State Office of General Services, Procurement Services Department solicited an Invitation for Bids that went through the competitive procurement process and negotiations for Furniture, All Types (except hospital room and patient handling). Award was made to all qualified bidders that could provide for conference furniture (seating and tables), dormitory furniture, general purpose tables, high density filing, household furniture, library furniture, office furniture, school furniture (found in classrooms for elementary schools through college), specialty seating (includes big and tall seating, bariatric, gang seating and laboratory stools), systems furniture.

The State of Florida Department of Management Services approved the Alternate Source Contract June 14, 2019, providing for conference furniture (seating and tables), dormitory furniture, general purpose tables, high density filing, household furniture, library furniture, office furniture, school furniture, specialty seating, and systems furniture; this contract also includes inside delivery, which may be at an additional cost to the customer. The State of Florida has participating agreements with 46 firms. Board approval will provide the County opportunity to purchase furniture from any of the participating vendors through the contract expiration of December 1, 2023, or any renewals or extensions approved by the State of Florida.
