#### **EXECUTIVE SUMMARY:**

The Maintenance Department purchases heating, ventilation, air-conditioning (HVAC) parts, equipment, and supplies for repairs and upkeep of equipment at all district sites. Items are purchased on an as-needed or emergency basis to ensure all equipment and units are maintained and operating efficiently. Staff recommends approval of purchase from Johnstone Supply, Naples Armature, and United Refrigeration, all of Naples, Florida, as vendors have agreed to renew at the 21-23 contract terms. All vendors meet or exceed the requirements of the bid and are best able to service the District, offer the best pricing, and offer an overall general convenience for the Maintenance Department. An award to multiple vendors ensures that a source of supply is readily available to meet the needs of the District. The renewal is a 2-year term through June 30, 2025. The estimated annual exposure for each of the 23-24 and 24-25 school years is in the amount of \$250,000.00, for a two-year total of \$500,000.00.
