A) Approve Piggyback No. PB220082JJB to utilize pricing on the State of Florida Participating Agreement (Alternate Contract Source No. 78102200-21-ACS) through the National Association of State Procurement Officials ValuePoint Cooperative Purchasing Organization (NASPO) with FedEx Corporate Services, Inc. for courier services for small package delivery and express delivery services, on an as needed basis, through the contract expiration date of November 27, 2026, and any renewals or extensions approved by the State of Florida or NASPO, as approved in the departments' annual adopted budgets.

II. ITEM SUMMARY

Approves use of a competitively solicited contract through the State of Florida to use courier services from FedEx Corporate Services, Inc., on an as needed basis, through the contract expiration date of November 27, 2026, and any renewals or extensions approved by The State of Florida or the National Association of State Procurement Officials (NASPO). Expenditures will be on an as needed basis as approved in the departments' annual adopted budgets. Expenditures during Fiscal Year 20-21 were \$52,043.99.
